and sundry deposits, the dep sitors of which have died intestate in this state and the funds are in the custody of the banks; that the deposits have escheated to the state of Oregon; that in order to recover said es cheated property it is necessary to institute actions at law.

Governor Pennoyer said: "The instrifetions given by me to the district attorney were to file a bill of discovery requiring bank officers to answer certain interroga-tories as compelled by law to be given, and no trifling will be allowed in regard to the matter. If the courts issue definite or-ders and bank officers disregard them they must be punished for contempt of court, and if there is not law sufficient to compet the answer I will ask the next legislature to enact one. If however, the courts triffe with the law by not stipulating a definite and limited time I will ask the next legislature to remove the recalcitrant judges from office. The law must be enforced. The banks may run the federal government but I do not propose that they will run the

First National of Sedalia. SEDALIA, Mo., Sept. 14 .-- W. A. Latimer receiver of the First National bank of this city, has filed a suit in the United States circuit court at Jeffereson City for \$358,000 against the directors of the suspended in-

stitution. The petition is of a sensational nature and makes public for the first time the alleged methods of President Cyrus Newkirk and Cashier J. S. Thompson, as well as those of the directors, in conduct business of the bank. Only three of the directors, E. G. Cassidy, H. W. Wood and John McClure, have property that can be reached by the suit. J. S. Thompson, th cashler, is a fugitive in Mexico and Cyrus Newkirk, the president, is now residing in California. In a nutshell it is charged that the directors allowed Newkirk to overdraw his account to the amount of \$101,000 and permitted Thompson to gamble away \$71,000 n stocks, wheat and real estate deals, be side allowing insolvent parties without se curity to draw \$90,000 out of the vaults. receiver alleges that the defendants, as diectors, during the whole time between tember 6, 1890, and May 4, 1894, utterly failed and neglected to perform their duties and failed to hold meetings of the board of directors to look into and after the affairs o the bank. They also signed and attested false reports to the comptroller.

MURDERED FOR HIS MONEY.

Kansas Miser and His Daughter Killed and Their Remains Cremated.

ATCHISON, Sept. 14 .- Meager details of a double murder have been received from a remote part of Jackson county, Kansas. Joseph Strong, an old residenter, who had the reputation of being a miser, lived with his 14-year-old daughter in a tumble down cabin on a lonesome farm, miles from any other house. Strong, though supposed to be quite well-to-do, was known to have no bank account, and the supposition that the gold was hid about his miserable abode led gold was hid about his miserable abode led those who knew him to urge him to pro-vide himself with better protection than was his custom. He paid no attention to their appeals, however. For several days past neither he por his daughter hal been seen, and an inquiry into his condition re-sulted. His cabin, was found in ashes. A further search revealed the charred remain of the couple. Nothing was found to lend clew to the authors of the crime, for such it undoubtedly, was. It is believed that robbers took all the money they could find and then fired, the dwelling to cover the crime.

their slumbers. Davis and his wife had been married twenty years, and she had borne him nine children. Their married life, however, had been far from happy. On June 5, 1892, Mrs. Davis repeated a previous threat to leave her husband, and wrote a letter to her sister. an adjoining county, to that effect. Davis flew into a terrible rage, but peace was restored, and at a late hour the little family etired to rest. Mrs! Davis slept in a bed with the two

youngest children, while her hushand occu-pled the floor with four boys, the other children being absent. Within a short time all were wrapped in slumber except Davis. It was then that he stealthily arose, and se which hung on the wall near his wife's bed, he approached the sleeping woman and dealt her a fearful blow across the temple. The blow crushed her skull, but fearing that his awful work had not been sufficiently well his awith work had not been summently well done, he dragged her to the edge of the bed, and again the heavy revolver descended with the same effect as before. Not a sound escaped the helpless woman, but the blood gushed from her wounds and streamed to the floor, Finding that life was extinct the murderer then took his victim from the bed and car-

ried her to the garden, where her lifeless and almost nude body was chucked into a potato hele and covered with dirt and leaves. Davis then returned to the house, washed the blood from the floor and went to sleep. In the morning he informed the children

that their mother had gone away during the night, but later he told the oldest buy she had committed suicide, at the same time cautioning him to say nothing about it. The boy, however, suspecting foul play, promptly informed the authorities. Davis' arrest and the discovery of the mur-At the time of the discovery of the body

Davis had not been removed from Ashleigh, and it was with the greatest difficulty that the officers prevented the women of the little town from lynching him. His trial was had in October of the same year, and he was readily found guilty of murder in the first degree, and chose shooting as the mode of death. When sentence was passed he astonished everybody by blurting out, "Well, there isn't any 'c:pper' on that, is there?"

His case was appealed to the suprem court of the territory and then to the supreme court of the United States, but the judgment of the trial court was not dis-turbed. The governor also refused to interfere.

Davis always claimed after his trial that he found his family physician and wife in a compromising position, and that he accidentally killed the woman while trying t wreak vengesnce upon her paramour, and the fact that the doctor committed suicide wthin a short time after the murder there are many who believe Davis' story.






