aged, but No Lives Lost. ARKANSAS CITY, Kan, Oct. 22.—Reports just coming tell of the ravages of a tornado of no small proportions which struck Geuda Springs, eight miles west of the Arkansas Waltemeyer, Hart, Swann, Van Camp, Tarwhen telegraphic communication is restored. As far as known there were no fatalities. Two people were known to have been injured. The property loss will aggregate nearly \$75,000. nearly \$75,000. The ternado struck from the southwest, and continuing in a north-casterly direction till it reached Winfield before spending its force. In its course it laid low farm houses, outbuildings, crops and trees. In Geuda Springs the springs bath house, which cost \$40,000, was partially wrecked, the Albright two-story brick block was unroofed, and the stores of M. A. Wells and Tom Royal were totally destroyed. Hubbel's business block and the Gilbert block also suffered minor lesses. also suffered minor losses. A Mrs. Bookwalter was caught in the wreck of the bath house and almost buried beneath a pile of bricks and aimost buried beneath a pile of bricks and mortar. Miraculously enough she es-caped serious injury. Dr. Duffield was seriously hurt, but not fatally, by being thrown from his buggy. The aggregate money loss at this point is about \$20,000. 
