Bession of the National Council of the Order Opened Yesterday.

WELCOME GREETING BY MAYOR BEMIS

National Councillor's Address Reviews the Good Results of the Last Year and Expresses Great Rope for the Fature -Finance Committee Divided.

At the Young Men's Christian Association auditorium the National Council of the Junior Order of United American Mechanics is in There are 150 delegates present, they coming from all portions of the United States, the east particularly being largely represented. It is the first time within the history of the organization that a national council has been held west of the Mississippi With grateful realization of this fact, J. W. Houder of this city, representing the local branches, has prepared a program of pleasure, including a carriage drive, banquet, reception, and incidentally a "camera party," the latter photographic adjunct being regarded as indispensable to conventions in Omaha.

Each delegate has his breast profusely decorated with patriotic colors, while the Denver delegation, working with indefatigable energy has placed "Denver for Next Place of Meeting" badges on every coat lapel.

At yesterday morning's assembly J. W. Houder introduced Mayor George P. Bemis, who welcomed the delegates and extended the proverbial key to the city's gates. Mr. Houder responded in a brief but happy

Perry Shaner of Pittsburg, in behalf of th National Council, extended a welcome. wished to correct the impression that the order was anti-Catholic. Mr. Shaner con-tended that the organization was loyalty to public achools, a defense of the flag and pro-tection of true American interests. The order was not opposed to any one who shared those sentiments, no matter what his creed

The meeting then resolved itself into executive session, the first order of business being purely routine, including the passing upon credentials, admission of new delegates and appointment of a committee to give unto the press such information with relation to the deliberations of the convention as the committee cared to divulge. COUNCILLOR'S ADDRESS.

National Councilor J. G. Richter delivered his annual address, which was in substance: 'We have assembled today in annual ses sion to review the work of the past year, and to legislate for the future welfare of our order. May the same kind Providence, which has permitted us to meet in this beau tiful city on the banks of the mighty Mis sourl, which parts our prairies, once more be with and direct us in our legislation, that it may redown to the good of our order everywhere. When one year ago you places in my hands, and entrusted to my keeping the gavel of command we little thought that teday we would be able to report our order in as good condition as it is.
"With employment hard to find, and thou

sands of our members only too willing to secure such work as would enable their to earn a livelihood, the stringency of the money market, and the gloom of despondency, as it were, hanging like a cloud over the land, made it appear to us as if we would be compelled to report a loss of mem-bership rather than a gain. But, during the past few months, the sun of prosperity has again smiled upon us, and the hum of the busy manufactories can again be heard of every hand, thus instilling new life among the people everywhere, and especially among the members of our order, so that today we are pleased to say that our order can be found away up in the Old Pine Tree state of Maine, where the Atlantic washes its rocky coast, in the land where our pligrim father first commenced an extended line of settle ments, and where the son of American lib cord and Bunker Hill; away out to the fruit ful and fertile fields of the prairie lands of the great west; beyond the lofty mountain regions, rich in mineral wealth, into the vineyards of California, until it touches the golden shores of the far off distant Pacific and from Manitoba in the north down the Pather of Waters, with its many tributaries to the gulf in the south, comprising thirty state councils, and subordinate councils i ten additional states, where as yet no state councils have been organized

After further reviewing the progress of the order in the various states for the past year.

the national councilor continued:

"To my mind the order is in far better condition today than it was a year ago, and I predict for my successor a more successful term than we have had. With business resuming on every hand, and an increased interest among our members of the successful factors are suming the summer of the s terest among our members everywhere. I fee confident that our future will be a bright one There are few, if any, orders in existence in our country today that have principles more grand, objects more noble, or teachings more patriotic than our order has, and if our members will only practice what they preach our future cannot be questioned. The new laws adopted at the last session caused us considerable correspondence and, in some in-stances, no end of worry. All this will be a gain to our successor, as I have no doubt that constructions will be placed upon cer-tain laws which will greatly lessen his work. There are some changes necessary, however, as I have had letters from different sections of the country inquiring as to the proper procedure during the closing ceremony, especially when repeating the F. recommendations for changes in the present general laws of the organization. FINANCE COMMITTEE CRITICIZED. Several committee reports were received, including the minority report of the national council legislative committee. The report

concludes as follows: "This is probably the first time in the history of this order that a minority report of a standing committee has been presented, but we leave it to the intelligence of the members to determine the committee of the commit bers to determine if we are not justified in our action, and we ask this national council to pass upon the principle involved in this report and determine:

"First-Whether or not the rights of each member of a legally constituted committee of this body shall be respected, and whether certain work outlined by a committee in regular session, can be set aside by an officer or certain members of the committee without first consulting all the members of said committee.

Second-To determine if the finance con mittee of the national council shall have the right to order warrants for salary, expenses stc., of a legally appointed committee of this body without sanction or authority of said

"Third-To determine by what right the finance committee of this body has authorized the payment of over \$1,400 in warrants for the national legislative committee when there has been no meeting since the organization of said committee, nor legal authority given by the members of said committee to incur these

"We think the settlement of these questions involving the rights of members on a com-mittee of this national council should be settled in order to avoid controversy and preserve to each committee the duty to which

has been delegated to perform by the officers of this body.
"In view of the experience of the past year we would recommend that this national coun-ell commit itself to the support of an imm gration bill and that all the power and influ-ence of the order be concentrated in that particular direction until consummated, leaving all other measures to some future time," PRED. SERVICE REFORMED

Many of the More Crying Evils Are Things of the Past.

THERE IS STILL ROOM FOR IMPROVEMENT

Annual Report of the Commission Proves that Conditions Are Improving Despite the Zeal of Farty Workers-Some Interesting Comparisons.

WASHINGTON, June 18 .- The forthcomng annual report of the United States Civil Service commission will show that the whole umber of persons regularly employed in the civil service of this country is about 2000000 Of these approximately one-fourth are in the classified service, subject to competitive examinations under the civil service rules. Of those in the unclassified service 22,000 are laborers, 5,000 are appointed by the president subject to confirmation by the senate, 1,500 are in the legislative branch of the government, and 2,666 are in the judicial branch The civil service act excludes these classes from classification.

The total number of positions affected by the extension of civil service rules from March 4, 1892, to January 3, 1895, was 8,184 Of these, 5,537 were added to the classificservice by original classification, and 2,647 y transfer of places classified but except d from examination to list of places subject competitive examination. Since January 3, all employes of the Agricultural department have been brought into the classified service, except the secretary and assistant ecretary of agriculture, private secretary to each, chief of the Weather bureau and his private secretary, the chief clerk of departnents and his private secretary, and laborers

A comparative steatement shows that at ne end of President Arthur's administration the approximate number of positions classified was 15,753; at the end of Presiden Cleveland's first term there were 27,330, and at the end of President Harrison's admin istration there were 42,928 places classified. Executive acts brought 29,873 of the latter number into the service, while the 13,055 others, principally in postoffices, became classified by reason of growth from small offices.

PENSIONS FOR OLD AND INFIRM. Investigations made at the request of the commission show that the salaries of gov-ernment clerks in the principal foreign countries are lower than those paid by this gov-ernment, but the pay of higher officials is generally more than that here. In all of the rincipal countries an entrance examination, both mental and physical, is required before appointment to the service. The tenure of office is permanent, or during good bihavior, and after the employe has become incapaci-tated by reason of age, length of service or physical infirmity, he is retired with a pen-sion, the amount of which varies in propor-tion to the length of service, from one-sixth to four-fifths of actual salary. In some countries it is optional with the employe to retire after fifteen years of service. In other countries from thirty to thirty-five years of service are required before retirement. Females are not employed at all by some governments, while by others their employ ment is limited to the work of teachers, tele graph operators and positions in the posta

The investigations also showed that the lours of labor vary, in the far northern as well as in the tropical and semi-tropica countries the hours of labor are short. In nearly all, including the United States, the hours of labor of postal employes are longer The time allowed for lunch, the amount o annual leave with pay and the amount of sick leave with pay vary in the different countries. In some the hour for lunch or rest or annual leave is fixed according to the grade of the employe, the higher grade of employe being allowed more time than those of inferior rank. Many countries are more regard to sick leave than the United States.

An unusually large number of holidays allowed espe tries. They are as a rule religious ones Christmas and New Year's being generall: observed in the Euro ean countries. In som national events are also celebrated.

VIOLATIONS OF THE LAWS. The report gives an exhaustive review of he investigations of violations of the civil service laws. Among the postoffices or whose investigation the commission is stil engaged is that at Rutland, Vt. Postmaster Hanrahan charges that the republican employes of his office are conspiring against him, while they in turn charge him with making political removals. The case has been under consideration since last Novem-

The commission also lately called the atention of the Pestal department to the case of many Indiana postoffices which it regards as on the whole worse than those of any other state except possibly Mississippi. the complaint the commission stated its position as follows: "This commission holds that where a postmaster makes sweeping removals of employes and fills the vacancy by the appointment of persons of the opposite party, that there is a presumption that he is controlled in the matter by political considerations, and is to be so judged unless he shows to the contrary, the burden of proof resting upon him. Undoubtedly there are cases where such presumption will be overcome by a disclosure of the facts, showing that there was a justifiable cause for every removal, and that selections for appointment were made in strict conformity to the civil service rules. But even in some of these cases, although the record is technically the law has nevertheless been evaded. Many cases have come to the notice of the commission where employes of one political party were freely dismissed for offenses which perhaps justified the action, but which passed unnoticed when committed by employes of the opposite party. A public officer is not to be relieved of the charge of partisanship when he has applied different standards of discipline to persons of opposite politics. Moreover, when he finds it necessary to make sweeping removals of em-ployes opposed to him in political faith, it is his duty to make the public understand that he is not actuated by political bias by taking such affirmative action as will prevent the ecessity of making appointments from registers on which all the members are members of his own political party."
