



All sorts of depredations are committed every few nights.

According to the story told by Mrs. Fee ley. Salvador came to this country when a boy, and was given into their charge by the late Rev. Father McMenomy, at the age of 10 nge of 10 years. He was kept by them until last win ter, when he was married. Previous to the marriage, which did not meet with the approbation of his employer, a settlement was arrived at, and a receipt in full for all serv-ices performed was signed by Salvador. Feeley gave him \$100 a year during all the time he lived there, besides his board, room, and clothes, and when he grew up gave him the use of eighty acres of land. He also gave him a team, harness and wagon, the whole valued at \$600. The receipt in full is now in Feeley's hands, and bears the date of January 19, 1895, less than six months from the tim that Salvador discovered the alleged fact that he had been imposed upon, and commenced i sulf to recover the balance due him, of \$2,600 Feeley claims Salvador has been put up to this action by enemies.
