It was expected but he would make some practical suggestions, it having been given out that ne would recommend some measures of internal taxation, among them an additional tax on beer. A reasonable inference from his failure to say anything on the subject may be that he intended to convey to congress the intimation that he is satisfied with the present revenue legislation and will not approve any change in it. How congress will regard the matter remains to be seen, but in the absence of any recommendation from the president regarding the revenue the branch of congress in which revenue measures must originate may very properly and reasonably decide to let the subject rest. American Missionary Society Meets and Listens to the Report of Retiring Officers-New Board for the Ensuing Year.

NEW YORK, Dec. 3.-The annual meeting of the American Church Missionary society for the election of officers and the transaction of other business was held at the Mission house today. General Wagner Swayne. president of the society, presided. The first business was the reading of the annual report, in which the alleged defalcation of Secretary William A. Newbold and Treasurer Henry A. Oakley were commented upon. The report speaks of the defalcation as fol-

lows: "The past year has involved the society in severe humiliation and loss. An overhauling of the society's finances disclosed that the treasurer and the general secretary had each of them taken for his own use a large sum from the society's funds, received set of figures which he says represents years, and, as is so often the case, even with light finally by an accident. taken by the treasurer is computed by an expert accountant at \$21,823. the treasurer's charge, while the general secretary was put in immediate charge of the ociety's immediate receipts. The apparent result has been that each of them relied for immunity upon his knowledge that the other was in no position to bring the situation to light. The treasurer was a person who enjoyed in the highest degree the confidence of the community, while the general secretary hads for twenty-six years been the society's trusted superintendent. been the society's trusted superintendent. The treasurer found means with which to make good the sum for which he was are un :-The general secretary had nothing nor had he any one who was sufficiently interested n him to make good the amount.
