CHICAGO, Dec. 31.—Wheat had the old year goodbye with its bull head cocked on the side of its head and its nose in the air in derision of the discomfited bears. It closed with a gain of 5c, after an early decline of 1/2c. Corn and oats did not change their attitude, which was one of deliveries, but the cash market was weaker. Provisions sold off on increased receipts of hogs.
