Spanish Sentiment Concerning the United States Consul General to Cuba.

HIS REPUTED REPORT STIRS UP MADRID

Profound Sensation Caused at the Capital by the News that an Expression of Opinion Had Been Made.

(Copyright, 1806, by Press Publishing Company, MADRID, Spain, June 22 .- (New York World Cablegram-Special Telegram)-The profoundest sensation has been caused here by the news of the alleged purport of a report by United States Consul General Lee to President Cleveland on the state of affairs in Cuba, which report is said to be on the way from Havana to Washington.

The effect of the intelligence is difficult to exaggerate. All classes of the community are greatly wrought up, but the commotion is especially great in parliamentary and political circles. The lobbies of the senate were extremely animated just before Senator Comas began an energetic anti-American speech on moving an amendment to the address in reply to the speech from the throne, asking the government to annul all treaties between Spain and the United States. The impression is general among politicians and military men that the government will be requested to withdraw Consul General Lee's exequatur, if he really has expressed opinions as unfavorable to Spanish rule in Cuba as rumor credits him with having

The minister of the colonies introduced in the Cortes today a bill authorizing the gov-ernment to expend in the war in Cuba as much of the colonial and imperial revenues as may be necessary to secure success, and also asking for authority to negotiate unlimited loans or credit.

The Madrid press continues to lay much stress upon the closer relations likely to be established between Spain, France and Russia, when occasion arises. The markedly friendly welcome given to the French fleets in the ports of north Spain is hailed by Spaniards as a happy omen.

WATERLOO, Ia., June 22.—(Special Telegram.) Governor Boles was interviewed this afternoon in regard to the report that his candidacy for president was being opposed by certain parties in the Illinois democratic convention on the ground that he spoke in defense of Cleveland's action in sending troops to quell the American Railway union strikes in Chicago. The speech in question was one which he delivered as permanent chairman of the democratic state convention held at Des Moines August 1, 1894. In this speech he took strong grounds against the exhibition of mob violence which had taken place at Chicago and elsewhere during this period. In speaking of the matter Governor Boles said today:

"If the whole of the speech was published I do not think there would be any cause for complaint. It will be found that I made very prominent the fact that the tariff, by its effect in fostering trusts and propolies, brought oppression upon the laboring man and was thereby responsible for the strike. I made this point very strong in this speech on that occasion, for I believe it. I do not care to discuss the matter further for publication at this time, but I simply desire to call attention to the fact that I described the troubles which the country passed through at that time to place myself right before the people. Governor Boies said that he had under stood that an attack of this sort was to be made upon him at the Peoria conven-tion and he expresses himself as being perfectly willing to meet it.

Strongly for Free Coinage. INDIANAPOLIS, June 22 .- The democrats of Indiana are gathering in great numbers for the state convention, which will be held Wednesday. It is probable that two days will be devoted to the convention. The platform will be very strong, favoring free and unlimited, immediate and independent coinage of silver at the ratio of 16 to 1. The free sliver delegates will com-prise 1,500 of the 1,747 delegates, the majority of the gold standard element com-ing from Indianapolis. There is a long list of candidates for the various offices, the pros pects being that B. F. Shively of South Bend will be nominated for governor. R. C. The building came down with an awful crash, and the structure was in a moment a mass of kindling wood. There were a large number of people in the building at the time. Twenty Years Ago. NEW YORK, June 22.—Benjamin Bristow, secretary of the treasury dur President Grant's second term, died at home in this city today of peritonitis.

Bristow was taken ill only last Saturda:

Benjamin H. Bristow was born in Eik Told county, Ky., on June 20, 1832. He graduated at Jefferson college, Pa., in 1851, studied law and was admitted to the bar in 1853. At the beginning of the civil war. at a time when his state was wavering be-tween loyalty and secession, he entered the union army as Heutenant colonel of the Twenty-fifth Kentucky infantry, and was engaged at the capture of Fort Donelson and at the battle of Shiloh, where he was wounded. He afterward became colonel of the Eighth Kentucky cavalry and served through the war with distinction.

While still in the field he was elected to

the state senate for four years, but resigned at the end of two years, serving from 1863 to 1865. He was United States district attorney for the Louisville district from 1865 until 1870. The ability with which he filled these offices led to his appointment as solicitor general of the United States. In 1872 he resigned to become attorney of the Texas Pacific railroad, but soon returned to

he practice of law at Louisville. He was nominated attorney general of the United States in December, 1873, but not confirmed. President Grant appointed him secretary of the treasury on June 3, 1874, and this office he filled acceptably until the end of June, 1876, when he resigned owing to the demands of his private busi-

At the republican national convention at Cincinnati in 1876, he was one of the leading candidates for the presidential nomina-tion, receiving 113 votes on the first ballot Since 1876 he has resided in New York City, engaged in the practice of law, down to last Saturday, when he was stricken with the illness which resulted in his death. litizens' Mass Meeting Recommends a Finance Committee to the Directory.

ENDORSEMENT OF ITS PRELIMINARY WORK

Ready to Hold a Meeting and Come mence Active Work Soliciting Stock Subscriptions to the Exposition Company.

Another mass meeting of citizens was held in the Commercial club rooms last night in the interests of the big Transmississippi exposition. The meeting was about as large a one in point of numbers as the first one, but there were many mexchants and citizens in attendance who were not at the other. This was due in a measure to the fact that an invitation to be present had been issued to the citizenship in general, while the first meeting was more particularly for the heavyweight capitalists and business men of the city, whose support the directory of the exposition company felt they should have before appealing to the citizens as a body. This support having been promised in no uncertain way, the directory felt confident enough to invite all citizens at last night's meeting. The meeting was, therefore, in a sense more representative of the entire city than the previous one and their ap-proval of the exposition project was as emphatic as the other, although no such opportunity for enthusiasm was offered. There was but one matter up for con-sideration and that was the report of the committee appointed at the last meeting to devise ways and means to obtain the finances needed at once to start the work

passed unanimously. The report of the committee contained the recommendations agreed upon at the meeting of last Saturday afternoon, a re-port of the proceedings of which appeared in The Bee. It was presented by Georga W. Lininger. It was composed of but one resolution. In the first place the committee recommended that \$500,000 should be raised by stock subscriptions. Secondly, it recommended that the following committee appointed to raise subscriptions, and disburse the funds and to have full charge of the finances of the exposition: Herman Kountze, chairman; H. W. Yates, Guy C. Barton, J. H. Millard, Frank Col-petzer, Victor B. Caldwell, W. S. Popplepetzer, Victor B. Caldwell, W. S. Popple-ton, Frank Murphy, A. L. Reed, R. P. Kir-kendall, Casper E. Yost, E. He stated that the committee had spent three hours in discuss-ing the problem that had been presented. to it and had finally agreed upon the re-port. In regard to the amount that should be raised by stock subscription, he said that the members of the committee had varied between \$200,000 and \$1,000,000, but that after considerable debate \$500,000 had been decided upon as the sum.

In this connection it was stated by Mr. Lininger that it was not anticipated that more than 10 or 15 per cent of this amount would be called in by the end of the year. and that not more than 25 per cent would Mr. Lininger went on to State further that the committee had decided to recomend that the financial committee sho be given authority not only to raise this amount of money, but also to have the power of disbursing it, thereby placing on

its shoulders the financial burden of the exposition. marks W. B. Taylor asked if the commit-tee had considered the advisability of hav-ing bonds voted by the city and county, and what objections it had, if any, to such

In answer Mr. Lininger stated that the committee had considered that point fully. It had found, however, that funds for the preliminary work of the exposition could not be obtained in this way under the present charter. Under its provisions the city could vote bonds only for the improvement of parks. The proceeds could be spent upon of parks. The proceeds could be spent upon the improvement of the exposition grounds if they were located within the city limits, but the money was needed for other purposes at once. He stated that this condition could be changed at the next meeting of the legislature by means of amendments to the charter, but that would be too let its begin troop the project. There too late to begin upon the project. Therefore it had been determined to obtain the necessary money by stock subscriptions as

Lininger also stated that it was found that when expositions had been held in the past subscriptions by means of stock had always been found expedient, and that money had always been raised in that way. He laid stress upon the fact that the money was to be handled by the finance committee, if it was appointed by the directory, although this would act under the direction of the directory.

MONEY MUST BE RAISED FIRST. President Wattles, who acted as chairman of the meeting, laid emphasis upon the fact that it was positively necessary for the citizens to raise at least \$250,000 before the government appropriation could be obtained. He also held that at least this sum must be raised before the exposi-tion could be announced and advertised throughout this and foreign countries.

In answer to another question Mr. Lininger stated that the committee recommendager stated that the committee recommenda-tion was offered to the mass meeting for ratification. If the selection was ratified the list of names would be presented to the di-rectory for appointment. The committee, if appointed would have the financial man-agement of the exposition in its hands. A number of questions were asked regard-ing the character of the exposition company by Champion S. Chase, and President Wat-tles answered with a brief sketch of its his-tory. He stated that it had been incorpo-rated some six months ago as the Transmistory.
