DIVORCE CASE GIVEN A SECOND HEARING

Sister of the Wife a Disturbing Eles ment in the Household, but She Deutes Any Wrong Doing.

Judge Powell was engaged yesterday morning in hearing the testimony in a divorce case which broke the record in this county for genuine nastiness. The case was entitled "Frank O. Cassiday against Carrie T. Cassiday," and the ground alleged in the petition why a divorce should be granted the husband was cruelty, a number of instances being detailed.

One peculiar feature of the case lies in the fact that a decree of divorce was granted at the last term of court, the husband and a sister of the wife appearing in court and giving testimony in support of the allegations in the petition. It was stated that the wife did not intend to contest the case and a decree was entered by default. Afterward the wife appeared in court and told another story, and the decree was set aside, the hearing being set for yesterday. The story in the petition filed in the case was to the effect that the wife was vicious

It can always be pledged or disposed of. The market for ts sale is never closed and never depressed. The most ignorant native who wishes to sell a piece of jewelry knows its market value quite well. He can scarcely be heated,

Jewelry forms the greatest factor in matrimony. The most lowly bride has her stridham, which is occasionally equal in value to five years' income of the bride-groom. There is often a scarcity of cloth-ing, sometimes a scarcity of cooking pots, generally not a particle of furniture, but nearly always a stock of jewelry. The wife who hes no invelopments on bibling else. who has no jewelry possesses nothing else; she cannot be robbed. The family that does

not have jewelry is absolutely indigent. One of the greatest boasts of the jewelry owner is that his hoards cannot be taxed.
