Arrested on an Indictment Found in Franklin County, Iowa.

G. M. Bigelow, a solicitor connected with the secret benevolent society known as the Fraternal Union of America, was arrested yesterday afternoon by Sheriff McDonald at the request of Sheriff Tucker of Hampton, Franklin county, Ia., who notified Sheriff McDonald by letter that Bigelow had been indicted by the grand jury of Franklin county on the charge of "forcible deliv-ery."

A complaint was filed in Justice Foster's court at Hampton, Ia., charging Bigelow with having stolen a pair of trousers from a fugitive from justice, and he was arrested. As soon as the arrest was made Bigelow was notified and a reply was received that he had stolen a pair of trousers from a fugitive from justice, and he was arrested.
