Endorsement of the Principles Laid Down by the St. Louis Convention—McKinley's Administration is Commended.

DETROIT, July 14.—Leonard J. Crawford of Newport, Ky., was this afternoon elected president of the National Republican League.

While the contest for the presidency had all the appearance of a close struggle, the result was scarcely less sure to have been decided than battles by states were taken.

The second one being necessary to verify the first, in which the detailed result could not be determined, owing to the confusion caused by numerous changes of votes, and the persistent sifting of local differences in some of the state delegations.

The result of the second ballot was not announced because Mr. Crawford's opponents were not given time to make it unanimous before the figures were added up.

In this the gentleman from Kentucky had things heavily his own way. The only candidate feared by the friends of Crawford was F. L. Fleitz of Pennsylvania.

The Illinois delegate, who wanted the next convention held in Chicago, combined with those through a steering committee.

SEVEN LIVES LOST IN THE RAGING FLOOD

Victims Swept from Their Beds by the Rushing Waters.

FIVE OF THE BODIES ARE RECOVERED

Others Are Buried in the Great Mass of Earth and Sand Washed Down Where the Dam Broke.

POUGHKEEPSIE, N. Y., July 14.—The two large reservoirs in the Peshkill mountain range which supplied water to the towns of Mattawan and Poughkeepsie burst their walls at 2 o'clock this morning.

The water was released through the breach valley, causing ruin and death.

Five bodies have been taken from the wreckage left in the wake of the flood and three are known to be two and probably three more lying somewhere beneath the piled debris.

The bodies were swept away by the torrent. The names of those whose bodies have been found are as follows:
