Secretary of State Porter Rules on the Ballot Protest Cases.

ALLOWS ALL PARTIES TO GO ON TICKET

Arguments Presented on Both Sides Result in a Decision that Lets Whole Aggregation Before the Voters.

LINCOLN, Oct. 9 .- (Special)-The hearing of the ballot protest cases before the secretary of state occupied the entire day. The protest against the use of the title "silver

no part of the names shall be appropriated.

George W. Hibner of Lincoln speke in favor of the silver republicans. He contended that the voters would not be con-founded by the use of the title "silver republican." There was no pretense that they were republicans. They had adopted a platform of their own, and had adopted a new tame. He agreed that the voters had the right to have a ballot printed so that they might cast their vote without being confused by complications, but in this case there could be no confusion. The emblems were all different, and the intelligent voter would know that the silver republican party was a separate and distinct organization. The party had complied with the law relative to the formation of new parties, and was en-titled to a place. The statute did not prohibit the use of a part of the old party name. The distinction in the names was as strong as the distinction between Sam Jones and NOT REPUBLICANS AT ALL.

C. M. Lambertson said that the republican party had held its convention, nominated its ticket and filed the certificates, and there had been no protest. It was acknowledged to be the republican party and had a right to the exclusive use of the name. The silver republicans seek to convey to the voter the idea that they are still republicans, and that a vote cast for their ticket will be upholding the great republican principles and in addition be a vote for the free coinage of silver. This would be a deception. The dominant principles of the republican party are sound money and protection. The silver repub-licans are out of joint on all these questions. Instead of being in fact republicaes, they condemn the republican administration, endorse all the heresics of the populist and Bryan democratic parties, and yet seek to draw votes by filehing the good name of the republicans. It was intended to deceive the Mr. Lambertson reviewed the actions of the

epublicans last year. They had voted for W. J. Bryan, "a democrat or populist, or whatever you may call him," and after hav-ing been defeated last year were trying to catch votes for the opposition by styling themselves silver republicans. They had made no pretense of nominating republicans. They had nominated for supreme judge Mr. Sullivan, a lifelong gold democrat, and yet wanted to put his name under the title "sllver republican." He did not question the honesty of the republicans who believed in free silver. They had a right to believe as they pleased. If the republicans had endorsed free coinage at the last national elec-tion, the speaker declared he would have flocked by himself. A man has a right to do as he pleases, but he has no right to confuse other voters by adopting a name that does not mean what it says and which is pro-hibited by the statute. The contention that the voters would all be able to distinguish between the parties was not true. Governor Holcomb himself had never been able to tell the difference between a republican and a silver republican. The three fusion elements were all united, warshiped one god and sub-

scribed to the same tenets.

James W. Carr of Omaha made the closing talk for the silver people. He contended strongly for the right to use the word republican and entered into a discussion on the intent of the statute and upon decisions made in other states. He admitted that the silver republican party did not assume to be republican in any sense of the word. It was a distinct party and the man who could not tell the difference was not en-titled to the right of franchise.

Mr. Lambertson replied in a discussion on the intent and meaning of the statute, after which the hearing was adjourned. The decision was withheld until after the protest against the national democrats should be

The organization now calling itself the "national democratic" party had originated in 1894 and had continued up to this time. His recollection was that an organization had been maintained and state committees had been appointed each year. The first split in the democratic party had occurred in 1894 at the state convention, after Bryan had been endorsed for United States zenator and Holcomb endorsed for governor. Mr. Webster also read from ocratic party and it was a national party. the Century dictionary the definition of the word "any" to show that when the statute says no new party shall appropriate any of the names of the old parties it means that no part of the names shall be appropriated.

There was nothing in the word "national" to distinguish one party from the other. The use of the name would deceive the voters. They had no right to use the word "denocrat." The law had been passed by the legislature to prevent such an action on the part of a political party.

SAWYER EXPLAINS THE SITUATION. Mr. Sawyer, for the national democrats, said that this was the fourth time the rights said that this was the fourth time the rights of his party had been contested. Up to 1894 there had been no question as to what was the democratic party. It had always met and dominated democrats. In 1894 the convention had seen fit to nominate a populist for office and those who believed themselves to be democrats withdrew from the convention. Since then they had maintained an organization and had cast more than 1 per cent of the vote. This year his party had adopted a platform different from that of any other organization, but which was in harmony with past platforms and principles of mony with past platforms and principles of the democratic party. It was the same party, but the law passed by the last legislature had made it necessary to adopt a name different from that of other organizations. He could endorse the argument used by the counsel of the silver republican party this forenoon, in which they claimed that the law was much enthusiasm. did not prohibit them from using part of the name of another party. The argument that no part of a name could be used was an absurdity, as it would prevent the using of any letter in the name. The speaker knew of no national democratic party except the one to which he belonged. There had formerly been a national democratic party, but it had gone out of existence some time ago. In the use of the title now adopted no voter would be confused. They had not endorsed the nominees of some other party. There was no mixing up of parties. Men had been nominated whose politics could not be questioned. The argument by Mr. Dunn that the executive committee could not name Mr. Switzler was extremely technical. In ac-

cordance with decisions made in other states these points should be liberally construed.
Mr. Dunn closed the argument, in which he reiterated many of the statements he had made in the opening. He called attention to the fact that at one time the democrats had nominated a republican for president, and in state politics some of the men who were now claiming to be national democrats had favored the nomination or endorsement of republicans. He concluded with an argument to show that the use of the title "na-tional democrat" would tend to deceive the

The charge that the designation is deceptive, and whether from intent or otherwise, is liable to deceive the voters is in my judgment not well founded, for the reason that the silver republican organization asvered itself from the regular republican party solely upon the issue of the free coinage of silver, and I can conceive of no name they might have adopted to better express their political standing than "Silver Republicans."

Taking into consideration the fact that under our present form of ballot each ticket or set of party candidates will be printed in a separate column, with a distinct party emblem, and for the reason aforesaid that the very name adopted by the organization aforesaid designates the true difference between them and the regular republican party, I am constrained to believe that there is no reason why any voter should be deceived by the aforesaid party name. Therefore I am compalled to find that the protest of the aforesaid J. R. Webster is not well founded and is hereby overruled and that the aforesaid candidates of the party calling themselves "Silver Republicans" may properly appear on the official hallot under the designation of "Silver Republicans."

STOCKMEN MAKE MONEY FAST Danger that They Will Sell All Their Young Stock. RAPID CITY, S. D., Oct. 9 .- (Special.)

'Yes." said a prominent stockman of this city, "this is our inning. Not for years have the prices for stock been so good, and in my opinion the top notch has not been reached yet. Since early fall feed buyers from the east-have been scouring our ranges paying exorbitant prices for young stock. Last year many of the big stockmen rounded up their 1 and 2-year-olds and shipped them down into Nebraska and Iowa, where they were fattened on cheap corn. This fall the farmers are coming themselves and buy-ing for their own investment. The ranges are in prime condition, but a question that is confronting us stockmen with consider-able force is how to keep in the cattle businers next year when we are selling off all our beef cattle, our cows, helfers and calves. I have seen the time when calves were killed when first born on the range because it did not pay to raise them. Last week I sold 120 from three days to a month old for \$12 a head, and I suppose I shall regret the sale before spring. There has never been any trouble heretofore in buying all the young stock wanted from the Texas and Mexico ranges, but next spring it will be different. The chance of replacing our stock will be poor. I look for a rise of a cent on, feeders before spring. The man who keeps his young stock for another year will have a better thing than a Klondike strike. The ranges will be better this winter than for several years because there will be less feeding on them.
