them. It was said the dead man had been offered a job in a certain insurance firm in Georgia, which had agreed to advance him \$300 on his salary. Mention was also made in the letter that the writer had suffered for some time from insomnia and that he had taken large doses of the drugs found upon the table to produce sleep. The concluding lines in the epistle were: "I believe that the oral is going to produce sleep." The letter was unsigned.


