The Indians listened, but the sheriff's men, seeing it all, stood still in the snow.

STRATEGEM OF THE SQUAW.

Now the squaw spoke to the Indians, saying that she had seen a great many soldiers coming down the hill that evening and giving it as her opinion that the camp would be surrounded and that if the Indians resisted they would all be killed. When she had succeeded in persuading them that it would be best to surrender in case the soldiere should come, she sat down again. This, the sheriff concluded, was a signal for the men to advance, and the posse moved forward. When they were quite near the Indians were made aware of their presence by the snapping of a cedar bough, and the sheriff, knowing that delay would be dangerous, shouted to his posse to advance. At the sound of his voice the Indians sprang for their rifles,
