

COMMERCIAL AND FINANCIAL May Wheat Put in Day at Seaweed Prices. BIG DEALERS HAVE COMPLETE CONTROL

Northwestern Receipts Are Unusually Small, but Heavy Deliveries of Contract Wheat at Chicago Are Reported.

CHICAGO, Dec. 21.—Scalpers had another hard time of it in the wheat pit today. The clique bought on the slumps and sold on the rallies and kept the market in such a state of nervousness that the little fellows were badly frightened. May closed at 50 1/2, a decline after selling at above yesterday's final figure. Other markets followed the general course of wheat, corn declining 1/8, oats 1/8 and provisions 1/16.

May wheat opened easy and about 1/2 lower than it closed yesterday, at 50 1/2. Liverpool was only a trifle higher at the opening here and by some mistake the receipts of wheat at Minneapolis were at first reported at 80 cars. Chicago receipts were very heavy, amounting to 570 cars, of which 240 were of contract quality. Those were the reason for the opening weakness.
