QUAKERS PROVE A SURPRISE
Lead the Procession at Finish of the Bi-Centennial Varsity Boat Race.

CORNELL OVER THREE LENGTHS BEHIND
Wisconsin Third and Columbia Last—
The freshmen rowed in the Fresh-
man race with the Quakers in the Rear.

SARATOGA LAKE, N. Y., July 2.—The
freshman and varsity races of the Inter-
collegiate Rowing association were rowed
over two and three-mile courses, respec-
tively. The Cornell freshmen won the first
contest in 19:54.45, three and one-half
lengths ahead of Columbia, which finished
second through a splendid spurt in the
stretch which put its boat slightly over a
quarter of a length ahead of the Quakers' boat.

Pennsylvania, pulling the only paper shell
used in the contest, won the varsity race
by three and one-half lengths in the remark-
able time of 15:51.74. Cornell got into second
place after a lively spurt, with Wisconsin
leading the westerners nearly a length.
Columbia peddled across the line four and
one-half lengths behind Wisconsin.

The quadrangular race developed sur-
prises, namely, Pennsylvania's victory over
Cornell and Wisconsin's heading of the other
all through the first mile and its remark-
ably good work from the standpoint of the
disadvantages under which its members
suffered by reason of a long journey so near
the time for the race. Columbia's place in
the varsity had been so uncertain all along
that its finish was not a surprise.

The freshmen rowed in the most glaze-
water, but the varsity crews had a rapidly
increasing south wind at their backs, which
accounts in part for the fast time made by
the winners. The freshmen finished in
fairly good shape. Pennsylvania gave out
perceptibly at the last in its fight with Col-
umbia. The Cornell boys showed their con-
dition by rowing back to their quarters, a
distance of four miles. The Wisconsin
varsity crew had to row two miles to the
starting point for the lack of a launch. At
the finish of the varsity race two men in
the Cornell boat required a dash of water to
enable them to keep their seats. The Penn-
sylvania and Wisconsin crews finished
strong and the Columbia eight evinced con-
siderable exhaustion.

Start the Varsity Race.
The four varsity crews were at their re-
spective stake boats and ready for the word
as soon as the referee's boat reached the
starting place at 12:35 o'clock. At the pre-
tense of Columbia to the water first with
a thirty-six stroke, Pennsylvania second
with forty, Wisconsin at thirty-eight and
Cornell last with thirty-eight. Before half
a dozen lengths had been rowed the Wis-
consin boys, with their stroke, were urged
to the front, and at the stroke they had
a lead of half a length. Cornell, which
was trailing in the rear, put on a
spurt and was almost on equal terms
with Columbia, which was second. In this
they reached the flag, which they passed
with Wisconsin a length in the lead and
rowing a stroke that was pushing the boat
through the water at a terrific rate of
speed. Wisconsin, Cornell and Columbia
were rowing a thirty-four stroke and Pen-
sylvania thirty-eight. The speed shown by
the Wisconsin boys was a surprise to every-
body.

As the crews approached the second mile
Pennsylvania went up with a rush, rowing
a thirty-eight stroke, and before the two-
mile flag had been reached took the lead
from Wisconsin. The Wisconsin boys
pluckedly held on to second place, rowing a
thirty-four stroke. It was at this juncture
that Cornell was called to "shoot their
bolt." Colson called on the men to
go after Pennsylvania. The men
responded with a will, but their reserve
force, which was so important in the New
London contest, did not show itself, and
while they got upon even terms with the
Wisconsin boys, it was seen that the Quakers
were beyond their reach. In the last
mile Pennsylvania skinned over the water
like a seal, leaving three and one-half
lengths in the lead. Cornell and the Wis-
consin boys had a desperate fight over every
inch of the last mile for second place, the
difference being less than a length.

BURT'S SPECIAL IN A WRECK
Union Pacific President and Party Get
Shaken Up in California.

ENGINEER AND FIREMAN ARE INJURED
Accident Occurs on the Southern Pacific
About Three Hundred Miles
from San Francisco—None of
the Officials Hurt.

The special train of President Horace G.
Burt and other officials of the Union Pacific
railroad from this city was wrecked be-
tween Smithson and Delta, in California, on
Friday night. Fortunately none of the officials
were injured, although all received a
pretty severe shaking up. Both the engineer
and the fireman of the special train were
hurt, but their injuries are not believed to
be serious.

The following telegram was received by
Thomas M. Orr at Union Pacific headquarters
on Saturday morning: "Delta, Cal., July 1.
—Notify all our folks no one hurt. Every-
body well and happy. E. Dickinson. The
message had the effect of satisfying a
number of anxious fears that were en-
tertained at headquarters regarding the
safety of the party. With President Burt
and General Manager Dickinson were also
John A. Munroe, freight traffic manager; E.
L. Lomas, general passenger and ticket
agent, and Director Harriman. The news
of the wreck and the personal report of
General Manager Dickinson that all were
well was immediately communicated to the
family.

The accident happened on the Shasta di-
vision of the Southern Pacific railroad, which
runs along the Pacific coast in Califor-
nia. The party had left Portland and en-
route to San Francisco. Near Delta, Cal., about 300 miles north of San
Francisco, the engine jumped the track in
a deep cut. The train was shaken up, but
the four private cars that followed the en-
gine remained on the track. The cars
were those of the Union Pacific and were
drawn by Southern Pacific engines and
crew. The official party left Omaha
about two weeks ago for a trip over the
Oregon Short Line and the Oregon Railroad
and Navigation company's lines. They are
expected home the latter part of next week.

Port Arthur Route Day.
President A. E. Stillwell of the Port
Arthur route, has secured September 7 as
"Port Arthur Day" at the exposition, and
expects to make it one of the big days of
the season. Trains will be run from the
parts of the south, and no effort will be
spared to have a large representation of
southern people in Omaha on that date.

President Stillwell is the first to secure a
day for any part of the route, and he
no doubt feels that he has secured a point
to outdo each other in point of attendance.
The idea of having a Port Arthur day was
suggested to President Stillwell by A. E.
Patterson, and the plan met with the hearty
approval of the exposition directors.

Satisfied with the Depot.
Superintendent Bignell of the Burlington
spent the morning in looking over the new
depot and arranging for the removal from
the old depot to the new. The interior
finishing of the depot are completed, with
the exception of the furniture, and Mr. Bignell
said that the depot would have been in
use before now had not the furniture
been delayed, and that he thought the new
depot would be in use by Monday.
