Higher Foreign Advices Cause a Sharp Advance in Wheat.

CORN AND OATS ALSO IMPROVE IN PRICE

December Wheat Gains Three-Fourths of a Cent, Corn Half a Cent and Provisions Are Unchanged.

CHICAGO, Oct. 5-The strength developed by outside markets today, together with higher foreign advices, caused an ad-vance here in wheat. December closed with an improvement of %c. Corn rose 1-80%c. Cats advanced %%3.%c. Provisions left off at virtually unchanged prices. Advices from Liverpool reported wheat
