High Dignitaries of the Nation Present Greeting to Native Land.

FLAGS AND FLOWERS COVER CARRIAGE

Continuous Ovation from the Train to Place de la Concorde.

BRILLIANT OFFICIAL LUNCH IS TENDERED

Marchand's Desire that His Senegalese Sharpshooters Be Brought to Capital is Granted Through Woman's Intercession.

(Copyright, 1899, by Associated Press.) PARIS, June 1.- Marchand is here. There 4s great enthusiasm, but no noisy demonstrations. A few flags have been unfuried in his honor. Everyone he sees is favorably impressed by him. He arrived in Paris at 10 o'clock this morning and has been on luncheon at the ministry of marine, where he received a gold medal and a sword of honor. The Nile was prominently symbolized, too, on the sword handle by a crocodile and a palm tree. The company at luncheon was chiefly official. Many admirals, generals and other naval and military commanders attended, and they were all in full dress uniform. Marchand, as the chief guest, took Madame Lockroy, the wife of the marine minister, into the banqueting room. At luncheon Marchand pleaded with Madame Lockroy for his Senegalese charpshooters to have an opportunity to visit Paris. He told her that the prospect was their great incentive to exertion in the march across Africa. Whenever their courage flagged Marchand cried to them: "Boys, another strong effort to make sure of seeing Paris."

This electrified them. They are now all at Toulon, and he told Madame Lockroy that he strongly felt his promise should be kept and that their deep disappointment prevented his enjoying himself. Madame Lockroy repeated what he said, talking across the table to her husband, and all the company sympathized with the explorer. It is now settled that his brave blacks are to come to Paris.

The set-out of the table at luncheon was original, charming and poetic. The floral decorations were entirely of wild flowers, blue, red and white. Madame Lockroy thought Marchand and his companions would prefer, after their long sojourn in Africa, the flora of the French woods and fields to any other. Another consideration was that they are less staring. Willows

and grasses lent grace to the floral harmony. Marchand looks a hero after Victor Hugo's heart. He is stient, thoughtful, modest, without bashfulness. He might almost be an American, so strong an impression does he give of unaffected stolcism and dauntless firmness. His face is deeply frued and careworn, but the sweetness of his countenance is indescribable. He seems gentleness itself when the lines relax into a EMILY CRAWFORD.

## Crowd Greets Marchand.

PARIS, June 1.-The civil and military authorities and a big crowd of people went to the railroad station at Lyons at 1 o'clock this morning to welcome Major Marchand, the African explorer, on his way to Paris from Toulon. A great concourse began assembling around the depot here of the Lyons-Paris railroad at an early hour today. Members of the League of Patriots arrived in wagonettes decorated with garlands and flags.

A tremendous shout of "Vive Marchand" announced the arrival of the popular idol's train at 9:10 a. m. A victoria was sent by the minister of marine, M. Lockroy, to convey the major to the ministry of marine, where a lunch was given in his honor.

## FACTS FAVORING DREYFUS

Attorney for Wife of the Accused Addresses the Court of Cassation.

PARIS, June 1 .- The court of cassation at noon today resumed hearing the arguments n the application for a revision of the Dreyfus case. The same audience as on the previous days of the hearing was present, but the rest of the Palace of Justice was leserted.

Maitre Mornard, counsel for Mme. Dreyfus, resumed his speech. He reviewed the facts in favor of Dreyfus. Counsel expects to close his speech today.

Maitre Mornard's speech was largely a rethreshing of straw already thoroughly threshed out by MM. Ballot de Beaupre and Maneau. He warmly eulogized the report of M. Ballot de Beaupre and applauded the

conclusions arrived at by M. Maneau. Counsel for Mme. Dreyfus concluded with rotesting against the idea that even for the sake of the honor of the army might should dominate over right. He said the army itself was thirsting for honor and justice to be rendered, and he pointed out that the army could not be dishonored by the acknowledgment that a judicial error had been committed. Counsel then said: "I am awaiting your verdict, believing it Il prove to be the blessed dawn which will throw upon our beloved country the light of concord and truth." (Applause.)

The president of the court then announced that sentence would be delivered at one of the approaching sessions of the court. It is generally surmised that this means sentence will be delivered on Saturday at the opening of the sitting of the court.
