Fitzsimmons took a short walk during the forenoon, but took no further exercise. Late in the afternoon he drove to the Coney Island club house, accompanied by Frank Kenney, Jack Everhardt, Dan Hickey, Martin Julian and Kid McCoy. By the time the party reached the club house they were surrounded by a crowd of several hundred persons, none of whom was permitted to follow the champion and his companions into the hig building. As soon as Fitzsimmons reached his dressing room he and Kenney stripped to the buff and donned their fighting togs. They entered the ring and sparred fast rounds, only exchanging light taps. The work of both men was closely watched by a number of experts, the most prominent of whom was Kid McCoy, who has posted a \$1,000 forfeit in the hands of George Siler to bind a match with Fitz-

simmons.

Champion in Proper Trim. He is in perfect condition and showed a wonderful lot of speed. 


