Financial Condition of City Comes Up in a New Form.

OVERLAP WARRANTS MAY MAKE TROUBLE

Treasurer Koutsky Has Creditors on One Hand and the Law on the Other and Doesn't Know What to Do.

If the existing laws are strictly adhered to by City Treasurer Koutsky the holders of warrants issued to pay the overlap of 1900, which amounted to about \$12,000, will be compelled to sue the mayor and other city officials to recover.

When the fiscal year closed, on August 1, 1900, there was an overlap which amounted to considerably over \$10,000. As soon as the 1901 levy was made warrants to take up this overlap were issued and are still outstanding.

The law plainly prohibits city officials from spending any more money than can be derived from the annual levy and it further holds officials personally responsible for a violation.

And now the city is threatened with another lawsuit. This time Mrs. Ella T. Mullins is the plaintiff.
