AFFAIRS AT SOUTH OMAHA

National Banks Respond to Comptroller's Request for Report.

GENERAL SHOWING IS ONE OF INCREASE. From This the Officers Argue that Money is Kept Moving—Railroad Avenue Up Again—Magic City Gossip.

In response to a request from the comptroller of the United States treasury, the three national banks doing business in South Omaha yesterday prepared statements showing the extent of their business and the amount of deposits, cash on hand and loans.

On December 10, the date of the last call, prior to the one of yesterday, the deposits in the banks here amounted to \$4,101,196.19, while on February 25, the date on which the banks must figure their statements, there was on deposit \$6,606,704.59.

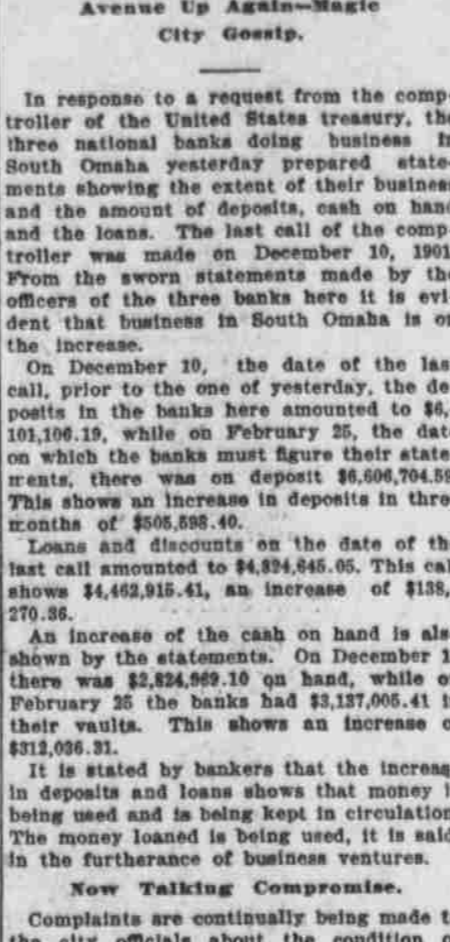
