Edward W. Miller Attempts Suicide, but Prompt Action Prevents Him.

DESPONDENT OVER LOSS OF POSITION Taken to the Hospital to Recuperate and Will Later Be Cared for by Friends of More Pros-

perous Days.

Despondent over financial troubles and ontinued ill-health, Edward W. Miller, until recently employed as a clerk in the railroad offices of this city for the last fifteen years or more, attempted Saturday morning to take his life by shooting himself with a revolver. The attempt was made at the boarding house of Mrs. Alice Creedon, 206 Fourth street, but was frustrated by Mrs. Creedon and other inmates of the house. The assistance of the police

Christian association hospital. Several months ago Miller was seized with a stroke of paralysis, for which he was treated at the Woman's Christian association hospital. He did not entirely recover and has been partially crippled and in poor health since. Two weeks ago he went to board at Mrs. Creedon's house. Having lost his position in the railroad office, Miller commenced to canvass for a subscription book, but did not make a financial success of it. He became exceedingly despondent and a few days ago threatened to commit suicide. Friday he went to Omaha for the purpose of seeking

employment. He returned Saturday morning and in the presence of Mrs. Creedon and two women boarders said he had failed to obtain work and had decided to end his life there and then. BILL TO CURB LIQUOR TRAFFIC Resolution Introduced in Prussian Diet Providing Restrictions of Rigid Character.

BERLIN, May 4 .- Count Douglas, a descendant of a Scotch soldier of fortune, has proposed a resolution in the Prussian diet asking the ministry to bring in a bill imposing more rigid restrictions on the liquor traffic
