Says Gas Company Too Low.

LEAVENWORTH STREET PAVING

Southwest Improvement Club Asks City Council to Order Repairs at Once.

W. H. Green, president of the Southwest Improvement club, has written a letter to the city council in which he makes com plaint as to the condition of the brick paying on Leavenworth street between Nine teenth and Twenty-sixth streets. This action was taken in pursuance to a resolution of the club at a recent meeting. The omplaint is that the bricks on this street between the points mentioned are worn out and that the street is rapidly becoming impassable. The writer points out to the council that quick action is necessary if the rights of the property owners are to be protected. He says that the contractor who laid the pavement guaranteed it for ten years and that the guaranty will expire January 13, 1903, so that in order to have the guaranty made good it will be neces sary to order the necessary repairs made before that time.

Mr. Green said: "We have had trouble on this street before. It is naturally low, and it may be difficult to maintain pavement. In fourteen years the property owners have paid for two pavements, and if something is not done by the council soon to compel the contractor to make good his guaranty we will be compelled to pay for three within fifteen years, or an average life of five years to each pavement. The first pavement was wooden blocks and like all of these pavements was a fraud. The gested. present pavement is supposed to be vitrified brick, but it was my opinion at the time they were laid, and I think that opinion is now borne out, that few if any vitrified bricks were used in the pavement, while in some cases the bricks put down seemed to be little better than ordinary building bricks. If the council will take the matter

up this summer the pavement can be repaired at the expense of the contractor, but if it is allowed to drag for six months property owners will have to make good the deficiencies in the work at their own expense. The pavement on the south side of the street car tracks is much worse than that on the north side, but nearly all of it will have to be replaced."

"Don't omit your name, your postoffice or your state when writing to department stores in cities for goods. Many people do omit one or more of these easential particulars, sometimes all, and it causes con-

fusion. "Don't think you can beat the game when you receive a polite letter from a stranger in a city telling you how to get rich quickly for nothing. You will be out of pocket and sadly fooled if you entertain

this popular belief. "Don't fail to prepay full rate upon your foreign mail, both letters and packages, even though the former will go forward to destination without any prepayment of

postage at all and the latter if partially prepaid. Double postage is collected abroad for the amount due. "Don't forget with domestic mail that while a letter will go forward if it has a angle rate of postage paid thereon, 2 cents,

the balance due to be collected of the addresses, newspapers and packages will not. They go to the dead letter office. People confuse these instances of foreign and do-


