TWO WARM FIGHTS ARE ON THE SCHEDULE

One to in Laneaster Over Party Control and Other is to See Who Will Be the Payored Congressional Candidate in Fillmore.

(From a Staff Correspondent.) LINCOLN, May 18 .- (Special.) -The reublican state convention is just one month off and while nothing very startling has yet developed outside of the withdrawal of Governor Savage, the intervening time promises to keep the political medicine mixers busy all over Nebraska. So far only two countles of importance have held their county conventions. Madison county led off nearly two weeks ago to give proper cercnony to the launching of the boom of Judge Robertson for governor. The state delegation selected was named by Roberton, and even the congressional delegation said to be subject to his command for the promotion of his interest. The only other delegation already chosen is that named in Adams county yesterday, and while on the surface it is not pledged, it supposed to be friendly to J. P. A. Black Franklin county, who counts on the support of substantially the entire Fifth district. For congress the Adams county delegates will start out voting for W. P. McCreary, and as the field of candidates is large the Adams county man may have

Renewal of Old Fight.

Two big fights are scheduled for this week-one here in Lancaster county and the other in Fillmore county. The contest in Laneaster is not a contest over candidates for state office, but over the control of the party machinery, and the nomina tions on the legislative ticket. All factions are publicly committed to H. H. Wilson governor, who can count sure on the vote of Lancaster county in the state con vention, but outside of this there is little agreement. It is the old fight between the friends of D. E. Thompson and the socalled antis. The Thompson element is now n control and their opponents have been vigorously endeavoring to inaugurate a Crawford county system of direct primaries nder which they think they would have less handicap in the race.

Each contending faction has its own set of candidates. On the direct primary ticket H. J. Winnett, candidate for state enator; O. W. Webster, W. J. Linch and O. B. Polk, candidates for representatives. the county's present legislative delegation Senator O'Neill and Representative John Mockett. Besides these two candidates on the administration ticket are Joseph Burns and E. T. Roberts, in the Third ward, J H. McClay and W. J. Lamb, in the Fourth ward. In the Third ward the administration will divide its support, according to precincts between Joseph Burns and E. T. Roberts, one of whom will likely withdraw before the convention meets on nex

Country May Settle It.

The opinion prevails among the more conservative republicans of the county that the eministration forces will win a sweeping victory. This faction hopes and expects to defeat all of the direct primary men in the caucuses tomorrow night, but it is maintained that even if one or all of the candidates are given their precinct delegations can be easily defeated with the aid of the country delegations. It is claimed that the country delegates as a rule are opposed to the direct primary system and ill register their objections by voting for administration men, who are supposed to favor retaining the present convention

Warm Contest in Fillmore.

another hotly waged contest is scheduled the Fillmore county convention on Tueslay, which will make known whether that county is to back the political fortunes of Charles H. Slean or Peter Youngers for ongress from the Fourth district. Both oan and Youngers are popular with Fillnore county republicans and each has ussally had their support for office by simply aying the word. This is the first time they ave both wanted the same office, and explains why both have been equally confident of coming cut on top.

Outside of these two countles, convenas will be held in Burt county tomorrow and in Otoe on Thursday, each of which will probably endorse a candidate for gov-ernor. Burt county is conceded to Speaker sears of the last legislature and Otoe to any of the friends of the late Senator Tayward. Then on Saturday comes quite bunch of conventions, including Johnson, olk, Cass, Pawnee and Red Willow counties. Polk will line up for J. H. Mickey for governor, and while the other counties may not present any favorite sons, they are likely to rally to candidates of their respective congressional districts.

After this week the conventions will, of urae, come thick and fast. Most of them have already been called, in fact all the principal ones except Douglas. The large umber of delegates apportioned to Douglas urally creates some interest in the probable disposition of its strength and some curiosity as to why its convention should held off so late. CREIGHTON MEETS IOWANS


Fast College Game Scheduled to Come Off on Local Grounds Today.
