PARKE WILSON GOES TO JAIL Denver Manager Arrested for Assaulting Umpire Swigert.

DISGRACEFUL EXHIBITION MARS A GAME

Enraged by a Decision Head of Grizalies Undertakes to Ent Offender

and Tries Policeman

for Dessert.

It remained for Parke Wilson, manager of the Denver base ball team, to break all records for rowdyism on the Omaha ball field. He made a most vicious assault on Umpire Swigert yesterday afternoon, and when the police interfered, changed his assault from the umpire to an officer. He was placed under arrest and sent to the city InIt

It was at the clope of Denver's man of the Beaumont, cf. eighth inning. Wilson, the last man to bat, Wagner, se... Bransfield, ib struck out. He was fairly wild with rage and rushing into the diamond, began striking wildly at the umpire. His judgment was no better there than at the bat, for he didn't hit the umpire any more than he did the ball. Swigert, with a sinister smile on his face, backed away from the enraged manager, beckoning for the police. Officer Gibbons reached the place first, and took hold of Wilson. Members of both teams rushed in to stop the trouble and several other policemen, with Captain Hayes, were on hand. Wilson, when turned by Gibbons from the umpire, struck at the officer, who morely turned him around and hustled him from the diamond. Off the grounds and to jail he went.

Offense to the Women.

Wilson's offense is all the more serious because fully half of the 4,500 people present were women. Manager Rourke has been particularly anxious this season to build up support among the women of Omaha, and his efforts have been quite successful. It is St. In nowise the fault of the home management that such an exhibition of rowdyism was New York afforded on ladies' day, but the effect can not but be bad. Wilson will, of course, be fined in police court for his assault on the umpire and for resisting an officer, but he should be expelled from the league as well. AMERICAN Here is an excellent opportunity for President Sexton to enforce the new rule laid down by the St. Joseph meeting and discipline a rowdy. President Packard will regret its necessity, but as he was one of the prime movers in the action taken at Et. Joseph, and has since publicly expressed his determination to have rowdyism stamped out of the Western league, he can not object to the disciplining of his obstreperous and

ungentlemanly manager. For the matter of that, the entire Denver team should be given some cautionary advice to say the least. Its stay in Omaha has been one prolonged kick. On Sunday, for example, during the double-header, not a play was made but was the subject of a ession by the Denver team, anywhere from three to six gathering around the umpire to "chew the rag." Nothing has been too trivial to hang a klek on. This sort of work is not ball playing, and does not contribute in the least to the success of the game. Captain Delehanty, Manager Wilson, First Baseman Davis and Shortstop Radcliffe have been the chief offenders, and should all be disciplined.

KNOCKS HOLE IN MULCT LAW Decision of District Court Which

Robs Injunctions of Their

Terrors.

SIOUX CITY, Ia., July 7 .- (Special Telegram.)-Judge Wakefield of the district court rendered a decision here today. which is of the utmost importance in the interpretation of the lowa mulct law, known at the Martin law, Judge Wakefield held the term "Owner," heretofore understood as meaning the owner of the property or building in which a saloon

was operated, applied to the actual owner of the saloon.

The method of the procedure in fighting alleged violation of the provisions of the Martin law, was to secure an injunc-This enjoined the owner of the tion. building and subjected him to punishment for contempt of court in case of its violation. In Sloux City, one of the most vigorous anti-saloon fights in the history

of the state, is being waged by the antisaloon league. Injunction proceedings were brought against Mel Powers. The league contended for the old interpretation of the law. Under this intrepretation the saloon keeper can file a bond and by the payment

of \$35 can secure an abatement of the injunction. The league will carry the case to the supreme court for final intrepretation. If the decision of the lower courtGranville is upheld, it will make procedure against Congalto saloons difficult, as by a change in name the saloon keeper can render himself free Baerwald from the operation of the law or by fake sales or by numerous other means. It vitually destroys the effectiveness of the Iowa mulct law.




