Bridge Watchman Observes Two Children on Fleating Log in Midstream.

NOTIFIES POLICE, WHO START TO RESCUE

Officers Watch at Foot of Douglas Street for Floating Log with Human Freight, but It Fails to Appear.

Two children who were clinging desperately to a log which was floating to the middle of the Missouri river were probably drowned yesterday morning between the East Omaha bridge and the Douglas street

The children were first sighted coming flown the river about 8:15 o'ctock by the watchman at the East Omaha bridge. They were clinging to a log, one on each side, and the log was whirling round and round in the water. The log and its human freight came from up the river and was seen as it went under the bridge. The watchman saw It come out below the bridge, but naving no means of rescue at hand could do nothing to save the children. He saw the log caught in a whirlpool and after being whirled around for a few seconds it shot down stream at a terrific rate of speed. He notified the yardmaster of the Omaha Bridge and Terminal company and he in turn telephoned the police station. It was thought by that time that the children would be passing the pumping station at the foot of Burt street.

#### Police Rush to Rescue.

Captain Hayes and several officers rushed to the Douglas street bridge and had the officers of Henrietta, the excursion steamer, lower several boats, in readiness to rescue the children. The officers kept a strict watch for over an hour, but the log and children failed to put in an appearance.

The news that a rescue would be attempted at the foot of Douglas street of the officers a hundred people had congregated. At one time a log was sighted from the bridge, upon which were two large knots. It was at first thought these were the children, and a rush was made for the boats. Before the men reached the log, however, their mistake was discovered.

It was then thought that the watchman had been mistaken. He was communicated with and said there could not possibly have been a mistake. He saw the children almost in the middle of the river and he was on one end of the bridge. Both children were partially under water and were helding onto the log, but it was impossible for him to tell whether they were boys or girls. It was the general impression that they had floated down from some of the flooded districts up the river. At the pumping station and at the city pound at the foot of Webster street the children were not seen. It is believed that they were drowned. Searching parties are out investigating, and it may be possible the children were washed ashere or were rescued somewhere below the East Oamha bridge.

It transpires that the bridge watchman who first saw the children on the log, believes them to have been tied to the drift wood and is sure that they were dead. He mays that as the log rolled shout the bodies made no motion and that they were in an unnatural position.

Their shoes were worn almost soleless and their feet are blistered and sore from coming in contact with the hard roads during the three days' trip.

Their clothing, though neat, tells of poverty. The girls are cousins and made their home girl until recently. Last spring, so the girls said, Mr. Miller died from the effects of a gunshot wound inflicted by a colored

Here are some of the new rules:

Coops in which live poultry is kept for sale must be large enough and high enough to "admit of the birds standing upright, with room to turn themselves without crowding."

Barber shops and hairdressers' shops must be kept clean and the floors must be mopped once a week with an antiseptic solution. They must not be used as dormitories. All tools must be sterilized after using; needles, tweezers, forceps and solssors must be disinfected in a 5 per cent solution of formalin. Razors must be wiped in a 85 per cent solution of sloohoi. Strops must not be wiped off with the hand or blown upon with the breath. The barber or hairdresser must keep his fingernalis abort and clean, Alum, used for stanching the flew of blood, must be applied only in powdered form and with a towel. Loose, hairs may not be blown from a customer with the breath, but must be removed with a brush or bulb, and it shall be considered a misdemeanor for a barber or hairdresser to undertake to treat skin diseases or barber's ltch; instead they shall advise their customers to consult a physician.

Conductors Must Telegraph. If a conductor on a train destined to

If a conductor on a train destined to Omaha shall discover among his passengers a person whom he believes is afflicted with smallpox or any other contagious disease, he shall, before arriving within the miles of Omaha, wire the mayor or health commissioner advising him of the fact. If it is impossible to wire, then the conductor shall carry the patient through Omaha.

No teacher or principal of an Omaha school shall permit a pupil to attend who has not been vaccinated within the preceding seven years and who cannot produce satisfactory evidence of such vaccination. It shall be the duty of the health commissioner to inspect the schools as often as he may deem necessary to satisfy himself that this rule is being compiled with. Skimmed milk, when offered for sale, must be in cans plainly marked with the words "skimmed milk," in letters at least two inches high. Any dairyman, having in his family a case of sickness of more than three days standing, must report the fact to the health commissioner.

#### ENDS HIS MISERY IN DEATH Frederik Johnson, Hopelessly Crippled, Shoots Himself Through the Heart.

Frederik Johnson, who fell under a Union Pacific train near the Paxton & Vierling John E. Quatsoe has commenced a \$5.00 suit in the district court against Harry Fischer. The plaintiff alleges that he has been for some time a promoter of advertising and piano contests and that he has many customers who rely upon his honor; that Fischer has injured this reputation and standing by printing in the Trade Exhibit a card attacking plaintiff's methods of dealing with customers.

The public meeting in honor of Adjutant this afternoon. Johnson has been in St. Joseph's hospital since the time of the accident and would have been discharged from there in a few days. It is supposed that he became despondent over his hopelessly crippled condition.

The revolver could not at first be found but was later found in the possession of Bilby at his house on the bottoms. Bilby said that he heard the shot and went to the fallen man and shook him and thought he spoke. Bilby, who believed Johnson to be drunk, then told him to brace up, and appropriated the weapon, which was a cheap Purdy, Traveling Passenger Agent, Chicago. papers: new 32-caliber. Seth Patterson, who is stationed in the flag shanty, said Johnson got off an outbound car a short time before the shooting. He said that the man had considerable difficulty in getting to the roadway and that he used crutches.

Johnson came to this country from Skone, Sweden, about six years ago and worked in the Cudahy packing plant. Prior to the accident which cost him his legs he boarded at 1244 South Sixteenth street with a man named Henry Gustafson. On November 10 last Johnson jumped from a train near the iron works, slipped on a pile of rails and went under the wheels. He was taken to the hospital, where his expenses were paid by the Union Pacific and by subscription among friends. Axil Peterson and others had just gotten him a pair of cork legs and on these he walked for the first time when he went to his death. Word has been received at the Union Pacific beadquarters in Omaha from General Passenger Agent Lomax, who is at the Colorado Springs meeting, confirming this press report. Mr. Lomax succeeded in getting what concession his road demanded and then withdraw the order announcing the Union Pacific's withdrawal from the immigration bureau.

Officials in Omaha say there is some mistake in the report referring to the Southern Pacific and Santa Fe as having had demands from which they receded. As matter of fact, they say neither of these roads had made any complaints, and that so far as was known there was no reason why they should object to conditions as they formerly existed, for both got a lion's share of the traffic. It was the Rock Island that made the

first objections to the methods of the bureau and withdrew from it. The basis of complaint of this road was that since the completion of its El Paso route to the coast it did not get a fair share of the percentages and had to bear its proportion of the enormous expenses just the same. It is believed that these differences have been or will be cleared up before the transcontinental meeting adjourns and that the Rock Island will return to the bureau as did the Union Pacific, thus placing the bureau back on its feet with the exact that the Great Northern and Northern

Pacific have been added to the list since Medicines and Robber Goods.
