TROUBLE FOR FAKE RACERS

Leon Lozier and Ed Moore Are Now Under Arrest in Denver.

INDICTMENT STANDS AGAINST THEM HERE

Accused of Being Parties to the Celebrated Webb City Fraud, by Which Many Were Fleeced Out of Money.

Sheriff Cousins received a dispatch yesterday announcing the arrest of Leon Lozier and Ed Moore in Denver, Colo. The men are under indictment here on charge of conspiring to defraud Charles Gregory and William Barker of this city in connection with an alleged fake foot race at Webb City, Mo., last January. Anticipating their early arrest Sheriff Cousins two days ago sent to the Missouri state penitentiary, at Joplin, Mo., a requisition, papers, and as soon as they reach him will start for Denver to bring the men back. Under the indictment their bail has been placed at \$2,000 each.

Leon Lozier, who has made Council Bluffs his home for a number of years, is a well known sprinter. It is alleged that he and Ed Moore "framed" up the deal whereby Gregory and Barker were induced to go to Webb City and part with their bank roll, amounting to over \$5,000.

According to the testimony of Gregory and Barker before the grand jury, they were induced by Lozier and Moore to go to Webb City to witness and place their money on a foot race between Lozier and John Grim, who is known in sporting circles as "Cash" Grim. They were given to understand that the race would be a "block" and severely injured him about the head. The men were arrested after a long chase by the police in the patrol wagon. They are said to be employed by the motor company at Lake Monona.

Allege Misconduct of Jurors.
