The case of J. H. Rohrs against the Western Travelers' Accident 'association was on trial in Judge Estelle's court yesterday. Rohrs brought suit against the association to recover \$75 for indemnity for three weeks' disability due to accidental injuries. The association contended that Cats-30,000,000 bushels..... Barley, ryc. etc.-10,000,000 bushels Hay-5,000,000 tons... Butter and cheese... Poultry and eggs. Potatoes, fruits and vegetables... Rohrs was not entitled to this benefit for the reason that when he received the injury his certificate of membership was in suspension for failure to pay the assessments levied against him. The case was appealed to the district court by Rohrs he having been defeated in the justice






