(From a Staff Correspondent.) LINCOLN, March 7 .- (Special.) - Despon dent because her writings had been repeatedly refused by publishers, Mrs. Millicent Lawson, aged 25 years, attempted to end her life late this afternoon by taking a quantity of morphine. Physicians in attendance say that it will be almost impossible for the woman to recover.

Mrs. Lawson lived alone at 425 South Tenth street and for several days had been acting strangely. Today the neighbors notified the police. The matron went to the residence and found Mrs. Lawson in a dying condition. By her side was a bottle which had contained morphine and a letter stating that despondency had caused the writer to take her life. After enumerating her many troubles the woman closed the letter by saying: "I have decided to end my life by the morphine route."

Mrs. Lawson had been twice married, but had separated on each occasion from her husband. She aspired to be a writer and some of her writings had been published, but not enough to satisfy her ambitions. She left manuscript for a book which she desires published. Mrs. Lawson's malden name is Morse and she has a sister residing in Omaha.
