

Because of an informality that occurred during the trial, the fact that he was not in court when the jury returned its verdict, the supreme court reversed the case and ordered him re-sentenced. Judge Jessen made it nineteen years this time, taking into account the year he had served.

Now comes McCormick and makes the plea that having served a part of the first sentence the imposition of the second one forces him to serve a second sentence for the one crime and that this sentence is therefore invalid. It is urged in the writ of error filed in the supreme court this morning that the state can have but one satisfaction for a crime committed against its laws, that he has rendered such satisfaction while said judgment was in existence and while its satisfaction was being usisted upon by the state.




