More Than Three Hundred Million Tons Mined in United States.

ZINC MINERS HAVE INCREASED BUSINESS

Fort Riley Gets Five Batteries of Field Artillery and Fort Leavenworth Three, Eight Coming to This Department.

WASHINGTON, Sept. 30 .- A preliminary statement showing the coal production of the United States, prepared by Edward W. Parker, statistician, has just been issued by the United States geological survey. It shows that for the first time in the history of the United States the production of coal has reached a total of over 300,000,000 short tons, the actual showing being 200,930,659 tons, valued at \$373,133,843. The output of anthracite coal amounted to 36,865,710 long tons (equivalent to 41,289,596 short tons), a decrease of 23.376.850 long tons, almost 40 per cent more compared

The output of bituminous coal amounted in 1902 to 258,641,680 short tons, valued at \$292,113,906, as against 225,836,849 short tons. valued at \$238,406,419 in 1901

Lend and Zine Production.

In reports on the production of lead and zinc in the United States for the year 1902, which have been prepared for the geological survey, the total output of lead for the entire country is placed at 220,000 short tons, and of gine at 156,327 short tons. The lead production was about the same as in 1901, but there was an increase of about 10 per cent in zinc production. In the matter of lead, the report notes a falling of the production of the Rocky and an increase in the Mississippi region. Colorado has come an important producer of ginc ore the output for the year for that state being placed at 26,241 short tons, valued at \$2,544,-993. The production of zinc ore in New
