FIND BODY IN THE RIVER

Prove to Be Remains of Ernest Fodisch, Whe Disappeared Some Time Ago.

Hunters Who Were After a Duck The Had Shot Discover It in a Mass of Driftwood Lodged on

The body of Ernest Fedisch, who dis ppeared from his home on "the island," tract of accreted land lying between lake and the Missouri river, was found yesterday in the river. Fodisch was last seen by his relatives on Sunday, October 25, and at the time it was thought he had committed suicide by throwing himself into the river. A search, however, failed to locate the body at the time, although pipe and handerchief belonging to the missing man were found on the river bank. The body was discovered yesterday morning by two young men who were hunting... They had shot a duck, which had fallen into the river, and on going after the dead The body, bird discovered the corpse. which was lying face downward, was entangled in a mass of driftwood which had aught at what is known as the "third dyke" on the government riprapping, sixty feet from the river bank. The place is about a quarter of a mile below where Fodisch's pipe and handkerchief were found and where it is supposed he threw himself into the river. The body was badly bloated and partly decomposed, but was easily identified as that of Fodisch by John Morgal, his brother-in-law, and Chief of Police Tibbits, who had known him for a number of years.
