

BEQUEST TO MASONS FAULTY

William L. Elkins' Codicil Does Not Insure the Proposed

Orphanage.

PHILADELPHIA, Nov. 17 .- The bequest f \$240,000, or if necessary \$250,000, for the erection of a Masonic orphanage made by the late William L. Elkins has been de clared illegal by the register of wills of Montgomery county. This decision is due to the fact that the codicil providing for the gift was made within thirty days of the testator's death and is therefore inopuerative. It will be necessary to make provisions to pay out the sum to the Masonic home of Pennsylvania if the wishes of Mr. Elkins are to be executed.
