This means naturally in the ordinary course of business. that the grain south of the city will now go direct to the Gulf ports and Kansas City will not be able to handle it at all as it has formerly done. Now the Great Western, the Missouri Pacific and other roads come in with the rates which will allow Omaha a chance and our southern competitor sees its northern grain about to be diverted to Omaha. No wonder then

that Kansas City is up and doing. We can't blame them for making a play for all the readjustment they can get, but we can rest safe that nothing will be done which will put them in a position of more than a fair and even competition."

Be Due to Outside INVOLVES POINT IN LAND LAW

Charges of alleged jury tampering created a profound sensation in Judge Slabaugh's court yesterday, when the jury in the case of John T. Connolly against the Union Pacific railway made its report, after having been out forty-four hours.

Foreman Informs Court that Members Were

Approached During Deliberations.

Asked for Damages, Said to

Influence.

In this case the plaintiff lost both of his legs, having been run over by a Union Papurchase of some land in Arkansas, was cific train in South Omaha. His legs were cut and crushed into a pulp and it became necessary to amputate both of them. Connolly then began a suit for \$50,000 damages against the railway company, and the jury in the case disagreed.

Another suit was instituted in the case last week before Judge Slabaugh and was hotly contested from beginning to the conclusion of the argument Wednesday, when the case went to the jury. During the period of forty-four hours the jury continued its deliberations, and when the report was made Friday it was found that a hung jury had resulted. It was immediately after the verdict of the jury had been read that Adolph Siefken, its foreman, arose and said:

"Your honor, I feel that in justice to the court and to the contestants in this case it is right and proper that I should make a statement at this time. It is my belief, from what has recently come under my observation and from what I have learned indirectly through other parties, that certain members of this jury have been approached in this case. This has prevented us from arriving at a decision and is the cause of our continued deliberations. Otherwise a verdict for either one side or the other would have resulted."

After Foreman Siefken had concluded. Judge Slabaugh said that the charges made by Mr. Siefken were very grave ones and that they would be investigated to the fullest extent. The announcement made by Mr. Biefken created a great surprise. It is Judge Slabaugh's intention to probe the matter to the bottom.
