INTERNATIONAL LAW LIBRARY Northwestern University Receives

Gift of Rare Books from Former Student.

CHICAGO, April 29.-Services dedicating the Gary collection of continental law, a part of the library of the Northwestern iniversity, were held today at the university law school. There were speeches by Hon. John W. Foster of Washington, D. C. Hon. Jacob M. Dickinson and others. All of the foreign consuls in Chicago were present as guests. The collection is due to money contributed for the purpose by Hon. Albert H. Gary of New York, a graduate of the Northwestern university. It consists of about 6,000 volumes, including the codes. statutes, judicial decisions, leading law journals and a selection of legal treatises for the entire continent of Europe. Its purpose is mainly to provide material to an extent not hitherto found in this country, for ascertaining the existing law of any European country, as affecting the rights and duties of persons living in the United States and having interests in Europe.
