Suicide Results as Intended.



Divorce Case to Supreme Court. The case of Jennie Sautter against Frank Sautter, in which Judge Sutton gave a de-cree of divorce in favor of the plaintiff, will be appealed to the supreme court. Mrs. Sautter brought the suit on the ground of cruelty. Sautter was ordered to pay tem-porary allmony, sout declined to do so. He contested the suit, but his answer was thrown out because of his refusal to com-ply with the order of the court. 


