

tions which would make it more effective than at present. The claim frequently made by the railroads that the law would tend to make freight rates unprofitable to them, he declared to be unfounded. He urged that in all cases the orders of the Interstate Commerce commission should be binding and not be set aside unless it could be shown that they were in conflict with other laws. The vital defect with the interstate commerce law, he declared, was that the com-
