If, however, at the coming trial, Doyle is able to convince the jury that he was equally entitled to a share of the Devil's Own stock as well as the other two properties, he should secure a verdict about as large as before, but if the jury finds as before that he is only entitled to a share of the stock of the Tidal Wave and Bob Tail No. 2, under the finding of the supreme court the verdict must necessarily be greaty reduced.

The verdict secured in 1901 by Doyle carried with it judgment for costs amounting to \$8,047 and interest aggregating \$8,044. In order to take the case to the supreme court 200 and secure an arrest of judgment Burns had to file a supersedeas bond in the sum of \$650,000, which was furnished by three eastern bonding companies.

Beaman Is Acquitted.

F. R. Beaman, formerly local manager of the Equitable Home association, who was indicted on a charge of conducting a building and loan business without a certificate from the state, was discharged in district court yesterday, Judge Thornell, on motion defense, taking the case from the jury and ordering a verdict for the defendant. The outcome of the case was due to the fact that the state legislature in enacting laws governing building and loan companies falled to repeal the old ones, The result was that at the time this indictment was returned against Beaman there were laws on the statute books making the offense charged both a misdeamanor and a felony.
