GREENE AND GAYNOR LOSE

British Privy Council Decides Case in Favor of American Government.

FUGITIVES MAY COME HOME FOR TRIAL

Important Question Growing Out of Flight of Indicted Men in Decided After Appeal

CONDON, Feb. 8 .- The privy council rendered its decision this morning in the Greene and Gaynor case in favor of the American government.

Across Water.

The council reversed the two judgments of Justice Caron of Quebec, August 13, 1992, and ordered the respondents to pay the costs of the appeal. The council's decision caustically criticises the action of Justice Caron in releasing Greene and Gayner, and Caren's "extraordinary inter-

where a prisoner is brought before a competent tribunal charged with an extraditable offense, and is remanded for the express purpose of affording the prosecution an opportunity of bringing forward evidence whereby the accusation is to be supported; if in such a case on writ of habeas corpus a learned judge treats a remand warrant as a nullity and proceeds to adjudicate the case as though the whole evidence was before him, it would paralyze the administration of justice and render it impossible for proceedings in extradition to be effective.

Committee says he misapprehended Andrews' judgment and confused reasons. Caron's two judgments reversed. Gaynor and Greene ordered to pay all costs.

Judge LaFontaine, extradition commis sioner, before whom the case was being heard on its merits at the time of the habeas corpus proceedings, said today: Unless something unforeseen occurs the sheriff of Quebec will now have to deliver the prisoners to Governor Vallee at the Montreal jail, and they will then be brought before me and the regular trial, halted by the writ of habeas corpus, will be recommenced. I shall then, upon the evidence submitted, decide whether or not there is sufficient grounds for extraditing the accused.

Fugitives Will Not Talk.

QUEBEC, Feb. 8.-The news from London that the privy council had maintained the appeal of the American government in the Gaynor-Greene case was received with surprise in certain quarters here, while in legal circles the decision was rather expected. Owing to what was feared were constitutional defects in the bill, it having falled to repeal some other sections in the road law, Governor Mickey, on the advice of the attorney general, vetoed it. The present bill remedies these defects and has the approval as to its constitutionality of Attornev General Brown. The conference is enthusiastic over this bill and expects it will become a law without serious opposition.

The question of the advisability of effecting a permanent organization was then taken up and after a brief discussion, in which every speaker reported himself heartly in favor of the movement, a resolution to form such an organization was unanimously adopted and the following committee was appointed to prepare and present to the meeting a constitution and by-laws: J.
