Members of Grand Jury at Logan Are ou

Says He Signed the Statement Without Knowing Its Contents, but Another Juror Corroborates His Statement.

LOGAN, Ia., March 9 .- (Special Telegram.)-Evidence was taken this morning in the case of the State of Iowa against Thomas Dennison in support of the count in the Dennison motion to quash the indictment, in which it is charged that Elmer E. Thomas promised and agreed that all costs would be paid by the Civic Federation of Omaha before the grand jury to ascertain the amount of butter fat. It creased its capitalization from \$125,000 to indicted Dennison. Five members of the grand jury of 1904 were placed on the stand. I. G. Hammer and F. M. Terry swore that Thomas was in the grand jury room and made the promises before Dennison was indicted. Sidney Titt, F. M. Blackman and J. L. McClannahan testified that Thomas was in the grand jury room and had made certain promises, but to the best of their recollection the promises were made after the indictments had been returned. All testified that Thomas had promised that some of the costs were to be paid by persons other than Harrison county, and some testifled that Thomas was to pay all of the costs. Two other members are to testify this afternoon and arguments on the metion will probably carry the case into Fri-

I. G. Hammer repudiated the affidavit presented yesterday by the defense, in which he was made to state that he was only induced to vote for the indictment on assurance that outsiders were to pay the excense. Hammer declares that he signed the affidavit without knowing its contents and denies any collusion or contract in the finding of the indictment.
