



Superintendent Barrett Re-elected with Higher Pay.

C. L. Barritt was reappointed superintendent of the county poor farm at yesterday's session of the Board of Supervisors. His salary was raised from \$75 to \$100 per month, as he declined to serve again at his former salary. Supervisors Spencer and Setz were opposed to increasing the salary of the superintendent, but on the committee on poor farm recommending the reappointment of Barritt at the increased salary, Setz voted for it, Spencer's being the only dissenting vote. During the prolonged discussion on this matter it developed that the matron, who receiving \$25 a month, also wants an crease of salary, otherwise she will not remain there. The cook receives \$365 per year and an outside man \$25 a month. All of the employes from the superintendent

down receive lodging and board. Supervisors Setz and Spencer expressed themselves as of the opinion that the county was paying out too much for help at the poor farm, but Chairman Brandes insisted that despite the rather heavy expense of running the institution there would be a large saving in the cost of caring for the poor this year. He said he believed that the end of the year would show that at least \$10,000 had been saved by having the poor farm. As in previous years, the supervisors are
