



Legal Rights Not Involved.
It is charged by many that Mr. Rocke-feller has acquired a large proportion of his wealth by illegitimate methods and that to such Ill-gotten gains he has no moral right (legal rights do not enter into the discussion). Multitudes believe that uniaputed facts raise a reasonable doubt, to say the least, whether Mr. Rocketeller has a moral right to the money which he gives away. It follows, therefore, that until that reasonable doubt is removed.
I would not say that the prudential com-mittee has a right to accept this gift until that reasonable doubt is removed.
T would not say that the prudential com-mittee has a right to accept this principle. It has no right to reject it. The acceptance of ethical principles is not optional.
For more than twenty years we have deplored the fact that workingmen as a class refuse to attend church.
