CEREAL MILL STARTS TODAY

Conrad Geise Has Transformed Malt House for New Industry.

The wheels of a new industry in Council Bluffs will be put in motion today when the large cereal mill into which Conrad Geise, the veteran brewer, has completed transforming his malt houses on East

Broadway, will be put in operation. As a compliment to Mr. Gelse's business energy and faith in this city the Commercial club will visit the plant in a body this afternoon to witness the starting of the machinery. At the same time an invitation is extended to the public generally to visit and inspect the plant. The large mait houses have been entirely remodeled and equipped with costly, up-todate machinery, much of which was im-

ported direct by Mr. Geise from Germany. In starting this enterprise in Council Bluffs he has done so entirely with his own capital and has sought no financial assistance or bonus from the Commercial club or business men of the city.


