

> of Proscribed District Prove Effective.

That Chief of Police Donahue's order to keep lewd women off the streets at night is being enforced to the letter was more strongly demonstrated in police court Monday morning than ever before. It is not an uncommon occurrence to have any-where from a dozen to twenty-five women in Judge Berka's court every idonday morning to answer to a charge of being inmates of disreputable houses, soliciting on the streets and larceny from the person and other offenses equally as bad, but Monday morning only two women were arraigned for these offenses or similar ones. The order to have the negro women in the proscribed district discard their decep-

tive wigs is being enforced, too, as there has not been a complaint since the order went into effect. However, Chief of Detectives Dunn arrested Sadie Alcare Sunday afternoon for being drunk and using profane language on the streets, and Monday morning she was fined \$15 and costs. Carl Jensen, a young man from Fairbury, identified the woman as the one who robbed him of \$10 some weeks ago while he was in her place. Another colored woman was given ten days in the county juil for disorderly conduct. .


