The council Tuesday night passed ordinances creating paving improvement districts for Twenty-fifth street from Dodge to California, Davenport from Fortieth to Forty-third, California from Twenty-third to Twenty-sixth and Maple from Twentieth to Twenty-fourth.

The municipal asphalt plant did not run Tuesday owing to circumstances necessary in the sand drum and a spiral conveyor.

ELBOURN ON THE DODGE LAW

City Clerk Announces He Will Test Registration Feature in Courts.

SECOND SUIT PROMISED THUS FAR

Matter of Fourth Day of Registration is What is Pending the Brain of Mr. Elbourn.

City Clerk Elbourn has announced that he will try to have certain features of the Dodge primary election law tested in court before attempting to carry out proceedings relating to the registration of voters this fall.

"The question that I am most interested in having decided is whether or not a fourth day of registration, or upon the same day the primaries are held, is really provided by the law," says the city clerk.

"The Dodge law seems to arrange for registration on primary day, yet it does not repeat or bind that section of the general election law which says the registration of voters shall be done on three days within three weeks of election day and at no other time. This last phrase is what forces the issue, to my mind.

Wants Written Opinion. "If I understand the opinion of the city attorney correctly, he thinks the fourth day of registration must be accorded. I intend to ask him for a written opinion, but after I have obtained it I intend to have the question taken into court by some taxpayer as I do not care to act one way or the other without a specific order from the court."

Arrangements are being made by County Clerk Drexel for issuing the proclamation for the primaries. He plans to get the notice out July 20 and is now negotiating for polling places. This call has nothing whatever to do with registration, the latter being in the hands of the city government.

The Elbourn suit will make two that are promised attacking the Dodge law, the other coming from the socialists, who allege that the rights of suffrage are infringed upon by charging filing fees for the primaries, participation in the primaries being required in order to get tickets on the official election ballot.

AFFAIRS AT SOUTH OMAHA

Places for Registration and Primaries Are Fixed for This Fall.

COUNTY CLERK URGES EARLY ACTION

Mayor and City Clerk Move in Preparing for the Election and Compliance with New Law at Request of County.

Working in accordance with the wishes of County Clerk Drexel, the mayor and city clerk yesterday located the places for registration and primaries. The understanding between the city and the county is that the county pays the rental for the booths while the city is to supply the furnishings. These furnishings consist of railings, tables, etc. In addition to the rental the county pays for the supplies needed.

The following locations have been decided upon:

- First Ward—First precinct, Pitzsimmons barber shop, Twentieth and Missouri avenues. Second precinct, Wright's tin shop, Twenty-fourth and K streets. Second Ward—First precinct, Twenty-first and U streets. Second precinct, Twenty-third and U streets. Third Ward—First precinct, 678 South Eighteenth street. Second precinct, Thirty-fourth and U streets. Fourth Ward—First precinct, O'Brien building, Twenty-fifth and P streets. Second precinct, Kiker building, Thirtieth and Q streets. Fifth Ward—First precinct, Bradford-Kennedy-Lumber company, F street and railroad tracks. Second precinct, Lehigh company, Thirtieth and P streets. Sixth Ward—First precinct, Markey's bakers, Twenty-fourth and P streets. Second precinct, 48 Twenty-fifth street.

CITY OFFICIALS SORE.

A number of city officials are showing sore spots on account of the paving of Twenty-fourth street with brick being blocked by a remonstrance. When the remonstrance was filed it was hoped the flaws enough would be discovered to declare the petition invalid, but it looks now as if this cannot be done. Mayor Koutsky, along with other city officials, is reported as saying that not a penny will be put in on repairs to the pavement. Until recently the street gang used to haul a load of broken stones to the street and dump them. This is to be stopped and the people who use the street are to be punished for having signed the remonstrance.

On the other hand, the remonstrators assert that they will demand of the mayor and council that steps be taken to repair the street as soon as the 1906 levy is available. If this is not done the remonstrators threaten to take steps to tie up the street repair funds so that no improvements or repairs in any part of the city can be made. With every day comes something new in this paving fight and even the best informed city officials do not seem to know where they "are at."

UPDIKE ELEVATOR MOTORS.

These motors call for 450 horse-power and practically one floor will be given up in the elevator building for these motors.

The current necessary for the moving of these motors will come direct from the Omaha power station at Shely. There is some little delay in receiving heavy cables for these motors, but the electric light company figures that it will be ready with its motors as soon as the elevator is completed and ready for business. September 1 is the date set for the opening of the elevator.

MICKY DISPUTES LAWSON

Governor Thinks President Not Powerless to Secure Legislation to Curb Trusts.

While in Omaha Tuesday Governor Mickey expressed regret that Thomas W. Lawson had announced that he considered the president powerless in bringing about legislation to curb the powers of trusts, railroads and other combinations of wealth because congress would take the executive's hands.

"I hold no such views," said the governor, "for I have faith in congress as well as in the president. We all know that at present the house of representatives is willing to follow out the president's wishes and to act for the people. It has seemed as though the senate was standing out against regulation of the money and business powers, but in my own opinion the senate is being gradually forced out of this position. If the higher body of congress does not take this attitude at the next session the time will come soon when it will have to. It may take some time for the will of the people to operate on the senators, but it will be exercised sooner or later just the same. I am confident of this and do not share, therefore, in Mr. Lawson's prognostications that the government will not do anything to curb the great combinations of capital."
