DECLARES ASSOCIATION IS A TRUST

Taking Tip from Experience in Grain Case He Has Officials Enjoined from Destroying Records of the Association.

(From a Staff Correspondent.) LINCOLN, Neb., April 15.-(Special.)-Judge Letton of the supreme court, acting upon a petition nled by Attorney General Brown, this afternoon issued a temporary restraining order against the members of the Nebraska Lumber Dealers' association to prevent them from combining to restrain trade or control prices and to prevent the officers from destroying any of the records of the association. In substance the order is the desociation. In substance the order nigned by Judge Letion is as follows: It is ordered and adjudged that the de-fendants and their cierks, servants, agents, employes, attorneys and officers, and each of them, are hereby commanded and di-rected to refrain from in any manner mon-opuliang or attempting to monopolize the trade and commerce in lumber and other building materials in the state of Ne-brasks; and from preventing or attempting to prevent competition therein; and from unlawfully fixing or attempting to fix the price thereof in restraint of trade; and there ensors or corporations for the un-lawful phipose of preventing or limiting competition in the trade and commerce of lumoer and building materials not mem-bers of the Nebraska Lumber Lealers' association; and from creating or carrying out any unlawful restrictions in trade and commerce of lumber and building materials in the state of Nebraska until the further order of this court. It is further ordered and adjudged that signed by Judge Letton is as follows:

That each member is re-quired by the rules of the association to pay in advance annual dues of \$7 for each lumber yard operated by him; that any wholesals dealer, manufacturer or manufacturer's agent who "shows himself to be in full sympathy with said asso-ciation" and its members might become, under the rules of the association, an honorary member, and as such honorary member, is required to pay annual dues of \$3. 




