maha Heavy Shippers Feel that They Are Hard Hit by New Rales.

RAILROADS SAY NEW LAW IS TO BLAME Change is General and Not Solely Applied to Omaha and Will Be

in Effect TIII Changed by Appenl.

The special committee appointed by the heavy shippers of Omaha, is very active in getting together evidence for the case which they say will be brought against he Western Car Service association, which composed of all the roads doing business in Omaha. The car lot shippers have decided to pay no more unjust demurrage tharges, and several cases are now pend-ing where the tailfonds have sold the care peause the firms refused to pay the heavy demurrage charges which the shippers plarge were clearly the fault of the railread companies. The shippers say they had companies. The shippers say they had get no saturation, for the car service puople do not perform the service, and tasy are sent from the railroad company to the car service association and back again, all the while the car running up comprehence bills. conurrage bills

Faw actual changes have been made in e reading of the rules of the Western Bervice association. The first rule is sled and reads: "All car load freight, a i freight taking car load rates, and all feeight cars, whether full car loads or not. taking track delivery, will be subject to ear service rules." Another phange is the abelishing of the special rules, which gave cout man five days to unload, and also the rules giving the shippers a day to hold a car when it is to be reconsigned.

On the Railroad's Side.

As presenting the railroad's side of the controversy H. H. Churchill, general agent of the Chicago Great Western railroad, said:

"The railroads are simply protecting their own interests and trying to minimize the abuse of their equipment, and at the same time to do it lawfully. The new law provides that all rates and charges must be reasonable, and as these charges are made in accordance with the law the shippers will have recourse in the courts if they think the rules are not fair. The railroads have established these charges and the burden of proof is on the shippers or those making complaints. The charges established by the roads are going to remain in effect and stay in force without any discrimination

until changed by the proper authorities. Not Snap Judgment.

These rules are no snap judgment, put in effect in Omaha alone, but are now in effect all over the country. The Great Western has incorporated them in its new tariffs, as is required by the new law. The coal men are the principal complainants because the special ruling in their favor is giving them five days in which to unload their cars has been removed by the new law. This law says all ship pers must bestreated alike, and the roads felt that they discriminated in favor of the coal man when he was given five days other shippers but two days. If in obeying the letter of the law we have imposed an unjust burden they have their ourse at law,

TARIFF ON GRAIN IN DOUBT New Rate from South Dakots May Be

Held Up for Thirty Days.

Whether or not the Northwestern and Milwaukee filed their new tariffs on South Dakota grain to Omaha with the Interstate Commerce commission before the new law went into effect, is a question that now concerns the members of the Omaha Grain exchange. The exchange has as yet received no information that the tariffs have been filed, though it has been informed by the officials of the roads concerned that they have been prepared.

If the tariffs were filed with the commis sion prior to August 25, the new rates may go into effect on any date set by the traffic officials in the tariff sheets, but if they have not been filed, they cannot to into effect, according to the law, unti, thirty

days have expired after publicat on. It is probable, says an Omaha man versed in railroad matters, that the commission will reduce this required period to ten days, since the large shipping associations of the country have requested it. The commission has already promised to consider the change, and a decision in the matter is expected in a day or two.

The fear of members of the Grain exchange is that some complication or other, arising out of the workings of the new law will prevent them from getting rates on South Dakota grain within a reasonable period.






