METHODIST HOSPITAL BOARD. Trustees Meet to Elect Successors and Consider the New Law. LATTER KNOCKS OUT OLD LIMITATIONS.

The annual meeting of the Nebraska Methodist Episcopal Hospital and Deaconess Home Association was held Tuesday afternoon in the parlors of the First Methodist church. The meeting was called to order by C. W. DeLamatre, president of the board of trustees and after a brief devotional service Rev. William Gorst, presiding elder for the Omaha district, was chosen chairman of the meeting.

During the year the number of patients admitted was 770; discharged 745; from Omaha and South Omaha 111; from Nebraska, outside Omaha 464; from Iowa 141; from other states 74; deaths 24; patients 54; free patients 138; surgical cases 449. Nurses' work outside of hospital: number of days spent in nursing pay patients in homes 1482; nursing free patients 441 days; number of days spent in free dispensary at medical college 44; graduate nurses into homes 138. Employed in hospital: deaconesses 13, nurses 41, women helpers 2, male helpers 5, correspondence secretary 1, house physician 1.

CLARK NOT ON INSOBRIETY

Lieutenant Charged with Neglect of Duty, a Much Less Serious Offense. Second Lieutenant A. L. Clark of the Thirtieth Infantry at Fort Crook, who confessed to the charge alleged against him before the court-martial which sat at the fort yesterday to hear that and the charge of insobriety against Captain Ralph R.
