Then, healthy cattle consigned to the quardivision causes a serious mixup in the wards, and there is liability of infection from diseased stock which may have occuthe pens before the healthy cattle arrived. In this matter the greatest care is taken, however, to disinfect the pens occupled by diseased stock.
