Strong efforts, according to the committee, were made to secure the presence of Governor Johnson of Minnesota, who is considered by many the etrongest democratic presidential possibility in the west next to Mr. Bryan. But Governor Johnson sent down word that it would be impossible for him to leave the state just at that time, although he said he would like to attend, Folk Also Declines.

TILLMAN ASKS QUESTIONS

South Carolina Senator Wants to Know About Bond Issues.

TWO RESOLUTIONS INTRODUCED

They Direct Finance Committee to Inquire if Recent Treasury Transactions Are

Legal.

WASHINGTON, Dec. 9 .- The senate was

Little business was transacted beyond the introduction of bills. The resolutions of Senators Clay and Culberson, calling upon the secretary of the treasury for information concerning the recent bond issues of the government came up, but in the absence of Senator Aldrich their consideration was postponed until another day, WASHINGTON, Dec. 9,-Senator Tillman today introduced resolutions directing the committee on finance to investigate the recent proceedings of the secretary of the treasury in connection with the financial crists and also to make inquiry concerning clearing house certificates. The resolutions were presented in two, the first dealing with the operations of the treasury department and the second with clearing house certificates, both being divided into three

subdivisions. The first of the resolutions directs the committee on finance to investigate and report to the senate as follows:

port to the senate as follows:

First, whether the issue of cortificates of indebtedness bearing 3 per cent interest, bids for which were invited by the secretary of the treasury. November 18, 1907, were for the purpose of borrowing money "to meet public expenditures," as provided by section 32 of the act approved June 16, 1898, and if not, where is any warrant of law for the issue of said certificates.

Second, whether the issue of \$50,000,000 of bonds of the Panama canal loan, bids for which were called for by the secretary of the treasury on November 18, 1907, was required to "defray the expenditures on said canal, there being at that time when both of these loans were made, upwards of \$200,000,000 in the treasury for current expenditures."

Third, "whether any legislation was necessary to protect the people and business interests of the country from the issue of unlawful money, if clearing house certificates are such, and to prevent the illegal increase of the public debt in time of peace."

The second series of resolutions direct the finance committee to investigate and report to the senate as soon as practicable," on Torpedo Boat Destroyers Succeed in the following points:

First, whether clearing house certificates which the country is now flooded have been issued under authority of law or contrary to the same. Second, whether the issuing of such certificates by an association of banks, both state and national, and the use of the same as money, subjects such certificates or notes to the tax of ten per cent provided in section 3412. United States revised statutes.

Third, whether it would be perminssible under the law as it is, for an association of banks, warehouses and elevators to issue certificates based on cotton, wheat and tobacco, stored in such warehouses and elevators, and fully insured, to be used as money in marketing said crops in the same way as clearing house certificates are used. The resolutions went over.

Senstor Culberson also called up his resolutions asking for information concern ing the issue of \$50,000,000 of Panama canal bonds and the total number of banks in operation on December 1 and November 18, 1907, and the amount of public money on deposit in the banks of each state and ter ritory on these dates. These regulations also were allowed to go over.

The same action was taken on the resoution concerning deposits of jublic money n national banks.

With only one committee appointed, that on banking and currency, and with the assurance of Speaker Cannon that no other committees would be announced until next sion, adjourned until Thursday.

ENJOIN SALE OF COLLATERAL

Creastors of Whitney & Stephenson, Stock Brokers, Take Steps to Preserve Assets.

PITTSBURG, Dec. 9 .- The creditors of Whitney & Stephenson, stock brokers, who filed a petition in bankruptcy against the firm Saturday, today secured a court order restraining all creditors who hold securities as collateral from disposing of the same antil the further order of the court.

The petition sets forth that the firm has labilities of about \$10,000,000, and that the ussets consist of stocks, bonds and other valuable securities held as collateral. is alleged that at the time the Pittsburg Stock exchange suspended its sessions these securities were worth \$12,000,000, but, that it is impossible, under present conditions, to place a value on them.

It is further alleged that the unsecured creditors hold claims amounting to about \$700,000 and that if these securities held as collateral are sold at private sale, as threatened, the unsecured creditors will get nothing. It is also stated that under a public sale, subject to the order of court. a fair value for such securities can be secured and all claims paid.

STATE AND INTERSTATE LAWS

Illinois Representative Introduces Bill to Obviate Conflicts of Jurisdiction.

WASHINGTON, Dec. 9 .- To so amend the Interstate commerce laws so as to enable and require the federal courts to recognise and apply the provisions of state statutes of the trial of interstate violations is the object of a bill introduced today by Representative Sabath of Illinois. The purpose as explained by the author of the bill is to obviate long delays in the conduct of interstate commerce cases by lack, or declared lack, of jurisdiction in the federal courts. The punishment provided is for the first offense a fine of from \$1,000 to \$5,000 or imprisonment for not less than three months nor more than five years, and upon subsequent continuation both shall be imposed.
