The intention of the authorities to enforce the mulct law in Council Bluffs is the direct result of Attorney General Byers' recent announcement that he had decided to spend the rest of his term of office in enforcing the state law governing saloons. This move on the part of Attoney General Byers was brought about by the recent

saloon troubles in Davenport A few days ago County Attorney Hess recrived a communication from the attorney general in which the latter stated that he had good reason to believe that the mulct was not being enforced in Council Bluffs, and "suggested" that it ought to be. Further, the attorney general expressed the opinion that there ought to be no delay in enforcing the law and enforcing it strictly. Acting on the "suggestion" of the attorney general, Mr. Hess at once sent notice to every saloon keeper in the city that the mulct law must be lived up to. When seen yesterday Mr. Hess said: "While Attorney General Byers suggested that the enforcement of the provisions of the mulct law be begun at once, I decided that no harm would be done by allowing the saloon men one week in which to make the necessary changes in their places. They will have a week in which to remove all screens, swinging doors and anything else which might tend to prevent a clear view of the interior of the saloons from the outside. It is my intention that the

mulet law be strictly and impartially enforced. No favoritism will be shown, and every saloon, no matter where located, will have to live up to the law now. Under the mulct law there can be no

screens, swinging doors or anything else that will prevent a view of the interior from the outside. No chairs or tables are permitted in the room in which the saloon is, and there can be but one door. The law also provides that all the liquor must be contained in the one room, and this means that beer cannot be kept in a cellar underneath the saloon and pumped up as is the case now in practically every saloon, There can be no music machines, slot machines or anything of such a character in the saloon. Under the mulct law saloons

must close at 10 p. m., and not open before 5 a. m. They must be kept closed on Sunday and all holidays and on election days.

The proprietor of one of the leading saloons of the city in discussing the county attorney's notice said: "I am not at all surprised at receiving this notice. Ever since the trouble at Davenport, and the part taken by Governor Cummins, I have will be all right if enforced without partiality, but it will be all wrong if some saloons are permitted, as they have been in the past, to evade the law while others have been required to obey it. 

At the meeting of the city council it is announced one or more of the councilmen will move to take the three water rate ordinances, introduced, respectively, by by Councilmen Fleming, Smith and Younkerman, out of the committee of the whole and take some action on them. Councilman Malonsy, it is said, will move to pass the ordinance at present in force, with the exception that it eliminates the minimum meter rate. Councilman Smith's ordinance. which does away entirely with flat rates and requires every consumer of water to use a meter, is said to be wholly impracticable. The putting in of meters would nocessitate an expenditure by the water works company of between \$40,000 and \$50,-000, and in view of the fact that it has not at present a franchise. It would not be likely to be willing to expend such an amount. It was said yesterday that Counofiman Fleming's ordinance would have enough votes to pass it.


#### Saloons Are Not Closed.



William Stewart Beaten to Death by W. H. Creviaton, His Business Partner.
